

**AMBETTER FALL 2022 NIKE TUA TAGOVAILOA MIAMI DOLPHINS LEGEND JERSEY GIVEAWAY
SWEEPSTAKES OFFICIAL RULES NO PURCHASE NECESSARY TO ENTER OR WIN. OPEN ONLY TO
