## **OFFICIAL RULES**

## **CINCINNATI BENGALS x 2023 SCHEDULE RELEASE SOCIAL SWEEPSTAKES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. BY ENTERING INTO OR PARTICIPATING IN THE SWEEPSTAKES YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES.

The Sponsor of the Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor" or "Bengals"), an Ohio corporation, with its principal place of business located at located at 1 Paycor Stadium, Cincinnati, OH 45202.
