CINCINNATI BENGALS x 2023 SEASON TICKET MEMBER AWAY GAME TRIP SWEEPSTAKES

ONE ENTRY ALLOWED PER ELIGIBLE PERSON. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED BY SPONSOR. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

The Sponsor of the Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor" or "Bengals"), an Ohio corporation, with its principal place of business located at located at 1 Paycor Stadium, Cincinnati, OH 45202.

1. **ELIGIBILITY; DURATION:** The Cincinnati Bengals x 2023 Season Ticket Member Away Game Trip (the "Sweepstakes") is open to all Bengals season ticket holders who (a) enroll (or are already enrolled) in auto-renewal on or prior to December 20, 2023 at 11:59 p.m. Eastern Time and (b) are legal residents of the continental United States and at least the age of majority in his/her state of residence at the time of entry, excluding residents of the state of Florida and New York ("Eligible Entrants"). For season ticket accounts held in the name of a corporation, partnership or other such business entity, the primary contact name listed on said season ticket account will be deemed the Eligible Entrant in the Sweepstakes so long as the primary contact is a legal resident of the continental United States and at least the age of majority in his/her state of residents at the time of entry. Void where prohibited.

2. **EXCLUSIONS TO ELIGIBILITY:** Employees, officers, directors, agents, and representatives of the Bengals, the Kansas City Chiefs, the National Football League, and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, prize providers and their immediate family members and/or those living in the same household of each are not eligible. An "immediate family member" is defined to mean spouse, parent, grandparent, child or sibling.

3. **HOW TO ENTER:** The Sweepstakes begins Friday, December 15, 2023 at 1:30 p.m. Eastern Time and ends Wednesday, December 20, 2023 at 11:59 p.m. Eastern Time ("Sweepstakes Entry Period"). Sponsor is the official time keeper of this Sweepstakes. The Sweepstakes is governed by these Official Rules and is subject to all applicable federal, state, and local laws. During the Sweepstakes Entry Period, Eligible Entrants may enter the Sweepstakes by completing the entry form found at Bengals.com/away and, if applicable, signing up for the auto-renewal payment plan via the Bengals Account Manager via the link in the entry form. To participate without signing up for the auto-renewal payment plan, an eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, telephone number and home ZIP code on a 3½x5" card ("Mail-In Entry") and mail it with sufficient postage to: the 2023 Season Ticket Member Away Game Trip Sweepstakes; 1 Paycor Stadium, Cincinnati, OH 45202. All Mail-In Entries must be received on or before Wednesday, December 20, 2023. Neither Sponsor nor its respective officers, directors, shareholders, employees, and agents are responsible for incorrect or inaccurate transcription of entry information. As part of the entry, Eligible Entrants must agree to these Official Rules and the Bengals Privacy Policy. Eligible Entrants must comply with all terms, conditions and requirements of these Official Rules; and must meet all requirements set forth herein. Use of any automated system to participate is prohibited and will result in disqualification. Entries that are incomplete, illegible, damaged, destroyed, late, misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from any and all Sweepstakes, at the Sponsor's sole and absolute discretion. Attempts made by the same individual to submit multiple entries by using multiple emails, addresses, accounts or other means may be disqualified. Entries generated by any automated means are void and may be disqualified.

Limit of one (1) entry per Eligible Entrant.

By submitting your Entry, you represent that your Entry conforms to the submission guidelines set forth below and with all of these Official Rules, and agree that the Sponsor, in its sole discretion, may remove your Entry and disqualify you from the Sweepstakes if it believes, in its sole discretion, that your Entry fails to conform to the submission requirements or to these Official Rules in any way. You may enter as often as you wish, but each Entry must be different and submitted separately.

4. **WINNER/PRIZE:** One (1) Grand Prize winner will be randomly chosen by a representative of Sponsor on or about Monday, December 18, 2023 to receive (i) two (2) tickets to the Cincinnati Bengals vs. Kansas City Chiefs game scheduled on December 31, 2023, at GEHA Field at Arrowhead Stadium in Kansas City, Missouri; (ii) two (2) round-trip coach air transportation from continental US airport to Kansas City, Missouri; (iii) one (1) hotel room for two (2) nights. Seating assignments at the game are at Sponsor's sole discretion. Total approximate retail value of the Prize is \$3,000. The Prize is non-transferable and awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. If potential Winner is unable to attend the game on the date specified in these Official Rules, the Prize will be forfeited and no other compensation will be provided.

All travel and accommodations are subject to availability. In the event the Cincinnati Bengals vs. Kansas City Chiefs game scheduled on December 31, 2023, at the GEHA Field at Arrowhead Stadium in Kansas City, Missouri is cancelled, Sponsor may, at its discretion, provide tickets and/or travel to a re-scheduled game or other event. Winner acknowledges, however, that Sponsor is not obligated to provide new tickets and/or travel to a rescheduled game or other event if the Cincinnati Bengals vs. Kansas City Chiefs game scheduled on December 31, 2023, at the GEHA Field at Arrowhead Stadium in Kansas City, Missouri is cancelled, and that Sponsor may indeed elect not to provide such tickets and/or travel. Sponsor may, at its election, assist Winner in arranging related transportation and/or accommodations and if so, has the right to use any cash portion of the Prize to cover such expenses. If in the judgment of Sponsor air travel is not required due to Winner's proximity to Prize location, ground transportation will be substituted for roundtrip air travel at Sponsor's sole discretion. The difference in value will not be awarded to the Winner. Travel is subject to the terms and conditions set forth in these Official Rules and to the following:

Flight schedules are subject to change without notice.
