## CINCINNATI BENGALS x BLACK FRIDAY SWEEPSTAKES

## NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

The Sponsor and Administrator of this Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor"), an Ohio corporation, with its principal place of business located at located at 1 Paycor Stadium, Cincinnati, OH 45202. The Cincinnati Bengals Black Friday Sweepstakes (the "Sweepstakes") is available through various promotional creative presentations ("Creative Presentation(s)") sponsored by the Bengals and by authorized sponsors of the Event ("Event Sponsors").

If the Grand Prize winner enters by subscribing to Bengals Blitz, he/she will receive two (2) Single Game Tickets and two (2) sideline passes for the Bengals game against the Baltimore Ravens on January 8, 2023.
