CINCINNATI BENGALS 2022-23 POSTSEASON RULE YOUR SCHOOL SOCIAL SWEEPSTAKES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. BY ENTERING INTO OR PARTICIPATING IN THE SWEEPSTAKES YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES.

The Sponsor and Administrator of this Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor" or "Bengals"), an Ohio corporation, with its principal place of business located at located at 1 Paycor Stadium, Cincinnati, OH 45202.

1. ELIGIBILITY; DURATION: The Cincinnati Bengals "2022 POSTSEASON RULE YOUR SCHOOL SOCIAL SWEEPSTAKES" (the "Sweepstakes") is open to legal residents of Ohio, Kentucky or Indiana who are at least the age of majority in his/her state of residence at the time of entry, subject to the additional requirements set forth in Section 3 below. Void where prohibited.

2. During the Sweepstakes Entry Period, eligible Entrants may enter the Sweepstakes by posting a photo of his/her school showing their "Stripes" and including in the post #RuleYourSchool and tagging @Bengals on Twitter, Instagram, or Facebook. Must be posted on Twitter, Instagram, or Facebook account that is officially affiliated with the school. Sponsor and its respective officers, directors, shareholders, employees, and agents are responsible for incorrect or inaccurate transcription of entry information. As part of the entry, Entrant must agree to these Official Rules and the Bengals Privacy Policy. Approximate Prize value is approximately \$2,600. The prize is non-transferable and awarded "as is" with no warranty or guarantee, either express or implied by Sponsor.

Sponsor is not responsible for and Winner will not receive the difference between the actual value of the Prize at the time of award and the stated ARV in these Official Rules. Failure to complete the Prize does not relieve the Winner of his or her tax obligations associated with winning the Prize.

Winner will be notified by phone or other means in Sponsor's sole discretion. Odds of winning depend entirely upon the number of eligible entries received.
