

HONDA SWEEPSTAKES (THE “SWEEPSTAKES”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING EACH APPLICABLE ENTRY PERIOD. VOID WHERE PROHIBITED BY LAW. ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT. TRAVEL NOT INCLUDED.

ELIGIBILITY: The Sweepstakes is open only to legal residents of the State of Ohio and Kentucky (the “**Eligible Territory**”) who are twenty-one (21) years of age or older at the time of entry and hold a current, valid Ohio or Kentucky driver’s license. Sponsor reserves the right to disqualify any entrant who does not qualify under all terms and conditions of leasing a vehicle from America Honda Finance Corporation (“**AHFC**”). Employees, officers, and directors, and their immediate family members (spouse, parent, child, sibling, grandparents, grandchildren, and their respective spouses, regardless of where they reside) and members of the same household (whether or not related), of Greater Cincinnati Honda Dealers Association (“**Sponsor**”), Cincinnati Bengals, Inc., (“**Bengals**”), the other NFL Entities and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any other entity associated with the Sweepstakes are not eligible to participate or win a prize.

All information submitted via Facebook and shared with any of the NFL Entities per your Facebook account settings, or submitted directly to any of the NFL Entities in connection with the Prize Notification process, is subject to, and will be treated in a manner consistent with, Bengal’s Privacy Policy accessible at Bengals.com/team/privacypolicy. If you do not have a Facebook account, you may register for one, for free, at Facebook.com. Data and usage rates may apply to the download and use of the Facebook mobile application. The time of receipt of any Facebook Entry shall be the time such entry is made available to Sponsor via the Facebook platform. Sponsor’s computer shall be the official clock of the Sweepstakes. Any entries that do not comply with the Content Restrictions or otherwise with these Official Rules and any that are removed or hidden prior to the drawing date are void. Failure to follow any Sweepstakes instructions provided by the Sweeps Facebook Account or these Official Rules may result in disqualification. For the avoidance of doubt, if an individual other than yourself appears in your entry, such individual must (a) be of legal age of majority in his/her jurisdiction and have granted you permission

to submit the entry or (b) if under the legal age of majority in his/her jurisdiction, be your child or legal ward. Sponsor may require you to verify such permission or parental status before declaring you eligible for a prize.

RANDOM DRAWING; ODDS: Five (5) potential winners will be selected by random drawing from among all eligible entries received during the Entry Period. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official secondary winners of the Sweepstakes. One (1) grand prize winner will be selected by random drawing among the five secondary prize winners of the Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period. Limit one (1) prize per person, family, or household throughout the duration of the Sweepstakes.

PRIZE: Six (6) Prizes Will Be Awarded, based on the order of random selection, as follows:

GRAND PRIZE: One (1) grand prize will be awarded. The grand prize winner will receive, subject to compliance with the requirements set forth herein, a two-year lease on a 2024 Honda Civic LX. The vehicle is subject to change. The lease will be based on 10,000 miles per year. The winner will be responsible for twenty cents (\$0.20) per mile thereafter. (Approximate Retail Value: \$12,000.) Winner must secure full coverage insurance for the term of the lease as specified by AHFC; must comply with all AHFC lease terms; will complete any and all necessary paperwork; supply any and all requested information and documentation that is requested by Sponsor. **REQUIRED INSURANCE COVERAGE NOT INCLUDED.** Winner will take delivery from an NOHDA member nearest Winners ZIP Code which has a vehicle available.

SECONDARY PRIZE: Five (5) prizes will be awarded. Each secondary prize winner will receive (2) game tickets and two (2) pregame sideline passes for secondary winner and one (1) guest to the Cincinnati Bengals vs. Cleveland Browns home game on January 6 or 7, 2023. **TRANSPORTATION AND LODGING NOT INCLUDED.**

PRIZE CONDITIONS: All prize details shall be determined in the sole and absolute discretion of Sponsor. Each winner is fully responsible for any and all applicable taxes (including income and withholding taxes). All costs and expenses associated with prize acceptance and use which are not specifically included in the prize description above, including but not limited to transportation, lodging, meals, gratuities, insurance, vehicle damage and other expenses, are the sole responsibility of the winner. Each prize is non-transferable and non-assignable, with no cash redemptions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute each prize (or any portion thereof) with a prize of comparable or greater value at its sole and absolute discretion. Use of any Bengals game ticket is subject to the standard terms, conditions, and health and safety policies applicable to the ticket. Seat locations at the game and, unless otherwise stated in the prize description, exact game date shall be determined in the sole discretion of Sponsor. Winner's guest(s) must be of legal age of majority in his/her(their) jurisdiction(s) of residence unless accompanied by a parent or legal guardian. Bengals game and times are determined in the sole discretion of the NFL and/or the applicable Club and may be subject to change. The terms and conditions of the tickets awarded as part of the prize will govern in the event a legal game, as defined by National Football League, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the prize. Sponsor and the NFL Entities reserve the right to remove or to deny entry to the winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, disparage, or harass any other person at the game. Released Parties (as defined below) will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Bengals

game. Bengals game tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game ticket. NOTIFICATION: Each potential winner will be notified via direct message to the applicable Twitter, Instagram, or Facebook account (as determined by Sponsor) provided at the time of entry (the "**Prize Notification**"). In the event that any potential winner does not respond to Prize Notification within twenty four (24) hours of the date of issuance or declines the prize for any reason, a disqualification will result, the prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. Any entry that does not comply with the foregoing, as determined in the sole discretion of Sponsor, will be disqualified.
