The Sponsor of the Sweepstakes is Gourmet Nut Inc. - 1. ELIGIBILITY; DURATION: The Cincinnati Bengals "POWER UP TRAIL MIX TICKET GIVEAWAY" (the "Sweepstakes") is open to all natural persons who are (a) legal residents of the states of Ohio, Kentucky and Indiana and (b) at least 18 years old at the time of entry. Void where prohibited.
- 2. EXCLUSIONS TO ELIGIBILITY: Employees, officers, directors, agents, and representatives of the Bengals, and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributers, advertising and promotion agencies, prize providers and their immediate family members and/or those living in the same household of each are not eligible. Winners will be selected two (2) weeks prior to each of the Bengals regular season home games at Paycor Stadium. Approximate prize value for each Winner is \$559-\$769. The prize is non-transferable and awarded "as is" with no warranty or guarantee, either express or implied by Administrator. If potential Winner is unable to attend the practice on the date specified in these Official Rules and Regulations, the prize will be forfeited, and no other compensation will be provided.

Winner will be notified by email after the close of the Sweepstakes Period. Odds of winning depend entirely upon the number of eligible entries received.
