OFFICIAL RULES AND REGULATIONS

CINCINNATI BENGALS x BLACK FRIDAY SWEEPSTAKES

The Sponsor and Administrator of this Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor"), an Ohio corporation, with its principal place of business located at 1 Paycor Stadium, Cincinnati, OH 45202. The Cincinnati Bengals Black Friday Sweepstakes (the "Sweepstakes") is available through various promotional creative presentations ("Creative Presentation(s)") sponsored by the Bengals and by authorized sponsors of the Event ("Event Sponsors").

1. ELIGIBILITY; DURATION: The Sweepstakes is open to all natural persons who are legal residents of the continental United States (except AZ, CO, CT, MD and ND), who are at least 18 years old at the time of entry a nd(a) who purchase single game ticket(s) to the Bengals vs. Browns home game at Paycor Stadium on either Saturday, January 6, 2024 or Sunday, January 7, 2024 or (b) subscribe to the Bengals email newsletter ("Bengals Blitz") as more fully described below. Void where prohibited.

The Sweepstakes begins Monday, November 27, 2023 after 12:00 a.m. Eastern Time and ends on or before Friday, December 1, 2023, at 11:59 p.m. Eastern Time ("Sweepstakes Entry Period"). Sponsor is the official time keeper of this Sweepstakes. The Sweepstakes is governed by these Official Rules and Regulations and is subject to all applicable federal, state, and local laws.

- 2.
