

OFFICIAL RULES AND REGULATIONS

CINCINNATI BENGALS x BLACK FRIDAY SWEEPSTAKES

ONE ENTRY ALLOWED PER ELIGIBLE PERSON. ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED BY SPONSOR. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW. BY ENTERING INTO OR PARTICIPATING IN THE SWEEPSTAKES YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES.

The Sponsor and Administrator of this Sweepstakes is Cincinnati Bengals, Inc. (the "Sponsor"), an Ohio corporation, with its principal place of business located at 1 Paycor Stadium, Cincinnati, OH 45202. The Cincinnati Bengals Black Friday Sweepstakes (the "Sweepstakes") is available through various promotional creative presentations ("Creative Presentation(s)") sponsored by the Bengals and by authorized sponsors of the Event ("Event Sponsors").

1. **ELIGIBILITY; DURATION:** The Sweepstakes is open to all natural persons who are legal residents of the continental United States (except AZ, CO, CT, MD and ND), who are at least 18 years old at the time of entry and (a) who purchase single game ticket(s) to the Bengals vs. Browns home game at Paycor Stadium on either Saturday, January 6, 2024 or Sunday, January 7, 2024 or (b) subscribe to the Bengals email newsletter ("Bengals Blitz") as more fully described below. Void where prohibited.

The Sweepstakes begins Monday, November 27, 2023 after 12:00 a.m. Eastern Time and ends on or before Friday, December 1, 2023, at 11:59 p.m. Eastern Time ("Sweepstakes Entry Period"). Sponsor is the official time keeper of this Sweepstakes. The Sweepstakes is governed by these Official Rules and Regulations and is subject to all applicable federal, state, and local laws.

2. **EXCLUSIONS TO ELIGIBILITY:** Employees, officers, directors, agents, and representatives of the Bengals, the National Football League, and their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, prize providers and their immediate family members and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply.

3. **HOW TO ENTER:** During the Sweepstakes Period, a person must either (a) purchase Bengals vs. Browns Single Game Ticket(s) through Ticketmaster or (b) subscribe to Bengals Blitz for a chance to win. Entrants will receive one (1) entry per number of Single Game Ticket(s) purchased (i.e., four (4) entries for four (4) Single Game Tickets purchased) and one (1) entry per valid email subscription (i.e., two (2) entries for two (2) subscriptions). Neither Sponsor, nor their respective officers, directors, shareholders, employees, and agents are responsible for incorrect or inaccurate transcription of entry information. Use of any automated system to participate is prohibited and will result in disqualification. Entry materials that have been tampered with or altered are void. Sponsor reserves the right, in their discretion, to cancel, modify, or suspend the sweepstakes should technical or other occurrences beyond the control of the organization compromise the administration, security, or proper play of the Sweepstakes.

4. **WINNERS/PRIZES:** One (1) Grand Prize winner will be randomly chosen on or before Sunday, December 10, 2023. The Grand Prize winner will receive one (1) football signed by Ja'Marr Chase. Odds of winning depend upon the number of eligible entries received. Prize Value for Grand Prize winner is \$500 or less. Winner must claim the Prize by picking the Prize up at Paycor Stadium at a reasonable time (e.g., during normal business hours or at a Bengals home game) to be mutually agreed upon. Sponsor may require proof of identity before handing the Prize over to Winner. The Prize is non-transferable and awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. If potential Winner is unable to receive the prize in these Official Rules and Regulations, the prize will be forfeited and no other compensation will be provided.

Winner will be notified by phone and/or email. If the Sponsor is unable to reach a potential Winner via phone and/or email within forty-eight (48) hours after a potential Winner is selected or if any message is not returned within twenty-four (24) hours, or if a potential Winner declines a Prize for any reason, then that potential winner will be disqualified and an alternate potential Prize Winner may be selected at random from the remaining eligible entries at Sponsor's discretion.

As a condition to eligibility to claim any Prize, potential Winner may be required in Sponsor's sole discretion to execute an affidavit of eligibility and any further liability and publicity waivers or other documents required by Sponsor. Failure to submit any required documents within the time period specified by Sponsor, or any other noncompliance with these Official Rules, may result in disqualification and Prize forfeiture.

Sponsor reserves the right to substitute any Prize with another of equal or greater value. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the Winners.
