

Sweepstakes Official Rules

3. Open to legal residents of the United States residing in New York State eighteen (18) years or older at time of entry. Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
