

Sweepstakes Official Rules
NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an ("Entrant")) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.

Sponsor(s): Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the "Bills") and La Nova Wings Inc., 4210 Union Road, Suite A, Cheektowaga, NY 14225 (collectively, the "Sponsors").
3. Open to legal residents of the United States residing in New York State eighteen (18) years or older at time of entry. Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
