


COMMUNITY BENEFITS AGREEMENT BACKGROUND AND PURPOSE

The Community Benefits Agreement (the "CBA"), drafted March 29, 2023, among Buffalo Bills, LLC (the "Bills"), Erie County Stadium Corporation ("ECSC") and the County of Erie ("County"), seeks to ensure participation by all segments of the local community in the economic opportunities available in connection with the design, construction, maintenance and operation of the new Highmark Stadium project ("Project"). Per the terms and conditions of the CBA, the Bills will make an annual Community Investment approximating a value of at least Three Million U.S. Dollars (\$3,000,000.00) to support the social, educational, and economic health of the Region.

Key stakeholders include (i) the Bills; (ii) Bills Stadium and Events Company, LLC ("Developer"); (iii) ECSC; and (iv) the County.

The CBA's objectives include, among other things: (A) fostering workforce inclusion and diversity in the Project; (B) addressing Prevailing Wage and Living Wage requirements; (C) enhancing supplier diversity and providing County business-priority for supplier and vendor contracts; (D) supporting affordable housing, food insecurity, educational access, social justice, and mental health initiatives in the County; (E) providing for commitments to local civic and other organizations; (F) furthering the Developer's cooperation in the economic development of the County; and (H) furthering the Developer's commitment to support youth and community programs in the County.

The Community Benefits Oversight Committee (CBOC), established to provide monitoring, oversight, and accountability in connection with the performance of the CBA, holds meetings in accordance with the New York State (NYS) Open Meetings Law. These meetings are open to the public and, in FY 2024, were hosted at the following locations throughout Erie County:





In FY 2024, \$464,525 was invested in resources and support to increase access to essential health resources, improve public health outcomes, and create a supportive environment for mental and physical well-being. These initiatives included:

Bills HeartBEAT

Through our efforts with the American Heart Association, Bills HeartBEAT continued its efforts to improving the
chance of survival during a cardiac arrest episode in our community. Over 70,000 people participated in handsonly CPR demos at Highmark Stadium. More than 5,000 individuals received CPR training at Buffalo Bills Training
Camp, HeartBEAT events, and other local activations, including the Buffalo Public Schools Summit and Niagara
Falls High School's Community Tuesday.

Crucial Catch

FOOD INSECURITY

CBA Section 2.(E)

In addition, through direct contributions to the Buffalo Bills Foundation, a community investment of \$289,573 was made to help address food security in Western New York. The Buffalo Bills Foundation is committed to strengthening food systems by investing in organizational capacity building, improving food access in both urban and rural communities, supporting community and economic development, advancing youth programming and nutrition education, and fostering community collaboration.





ECONOMIC DEVELOPMENT

Fueling the economic development and growth of Western New York to create lasting community impact is a key focus. In FY 2024, the Bills invested \$975,836 through inclusive business practices focusing on Supplier and Vendor Diversity, Small Business Support, Workforce Training and Development, and Apprenticeship Participation.

SUPPLIER AND VENDOR DIVERSITY

CBA Section 2.(C)

The Bills actively contract with diverse suppliers and vendors, specifically Minority-owned business enterprises ("MBEs"), Women-owned business enterprises ("WBEs"), and Service-Disabled Veteran-owned business enterprises ("SDVOBs"), for operations and services related to our business and facilities. SMALL BUSINESS SUPPORT AND ECONOMIC INCLUSION

CBA Section 2.(G)

As a part of efforts focused on Economic Development, \$605,763 was invested in Small Business Support and Economic Inclusion. The Economic Impact Team was created to promote opportunities related to the construction of the new Highmark Stadium, as well as nurture business growth and development within the Region. This team is a driving force behind the Bills' commitment to economic inclusion and include key additions such as full-time Economic Impact Manager, engaging NYS-certified MBE Modern Times Inc. as the Project's Compliance Consultant along with local NYS-certified MBE/WBE AA Report Writing & Consulting, and employing local NYS-certified MBE/WBE Developments By JEM to serve as the Project's Community Engagement Coordinator.

Through our investment in a dedicated Community Engagement Coordinator, Developments by IEM, a range of programs and services were provided to support small business owners and individuals, including:

Community Huddles

In FY 2024, hosted two Community Huddles in East and South Buffalo to share updates and information about the new Highmark Stadium project in support of regional business owners.

MBE/WBE Certification workshops

- Workshops were designed to assist small regional businesses with their Erie County and NYS MWBE certification applications.
- 78 small regional businesses registered and were pre-screened, with 44 participating in the program; 21 applicants submitted certification requests, 16 of which were approved and 4 remain pending.

Women in Construction Week: Ladies Lunch & Learn

The Ladies Lunch & Learn event brought together approximately 150 participants for an opportunity to connect, gain insights, and be inspired by successful women in the construction industry, with the goal of encouraging career growth and empowering more women to pursue opportunities in the field. Attendees included members of the new stadium project team, tradeswomen, women working across the construction industry in Western New York, and students enrolled in construction and construction-adjacent courses at Regional colleges and universities.





WORKFORCE TRAINING AND DEVELOPMENT, APPRENTICESHIP PARTICIPATION



Recognizing that the people of the Region are the backbone of the community, the Bills made a community investment of \$13,000 in workforce development and related initiatives, in addition to hands-on involvement and active collaboration in workforce development programming and community groups. This included the continued support and sponsorship for Be Your Own Hero's Career Experience and student programs. Through these events, the Bills provided opportunities for students and job seekers to connect with and pursue careers with area employers, promoting family-sustaining jobs and wages. Supporting and facilitating workforce development initiatives underscores the Bills' commitment to impacting lives on a personal level and fostering economic growth in the Region.

• Be Your Own Hero Career Experience Fair

• The Career Experience Fair was held on April 8, 2025. The objective was to help juniors and senior high school students learn more about careers in the trades, civil service and other direct entry careers. Held at Buffalo RiverWorks, 900 students from 36 different area high schools participated and had the opportunity to connect with over 80 employers and training programs representing a variety of industries.

As construction of the new Highmark Stadium continues, plans to incorporate additional design elements will be introduced, such as additional collaboration with the Niagara Frontier Transportation Agency and Erie County on Transportation Improvements, development of Sustainability and Recycling initiatives, as well as a Community Art Program developed collaboratively with local artists.















YOUTH AND EDUCATION

Youth and Education continues to be a focus for the Bills, with a FY 2024 community investment of \$693,437 dedicated to supporting programs and services benefiting our Region's youth. This investment reflects a long-standing commitment to advancing educational opportunities and enrichment through a combination of financial support and volunteer involvement and includes in-kind contributions of donated tickets, items, and experiences valued at \$296,422.

In FY 2024, the Bills invested \$332,865 to support a variety of afterschool and sports programs. Additionally, the Bills facilitated and managed the use of their facilities by community organizations and schools, ensuring that these spaces are available for sporting events and activities that benefit the broader community.

EDUCATION

In FY 2024, the Bills invested \$68,150 in education-specific initiatives, including scholarships and sponsorships. Beyond financial support, Bills staff also contributed their time and expertise by guest lecturing, speaking to student groups, mentoring, and participating in various education-focused programs. Full Team Community Takeover

 On May 22, 2024 the Buffalo Bills participated in a one-of-a-kind event as the team visited 12 local schools simultaneously for a surprise community initiative. 85 players and coaches participated with over 9,000 students impacted. Each school had unique experiences that included a panel discussion, field day activities, small group discussions, gardening, and much more. Each school ended with a school parade led by the players and coaches.

NEW HIGHMARK STADIUM CONSTRUCTION

MBE, WBE, SDVOB PARTICIPATION & WORKFORCE INCLUSION AND DIVERSITY

As construction progresses on the new Highmark Stadium, the Bills, alongside project management firm Legends Project Development, and construction manager Gilbane|Turner, remain committed to utilizing good faith efforts in achieving the project's Minority-owned Business Enterprise (MBE), Women-owned Business Enterprise (WBE), and Service-Disabled Veteran-Owned Business (SDVOB) participation goals, as well as broader workforce diversity objectives. Through FY 2024, Empire State Development's Office of Contractor and Supplier Diversity has reported project spending of:

MWBE AND SDVOB PARTICIPATION

The Bills are committed to achieving its goals set for Minority-owned Business Enterprise (MBE), Women-owned Business Enterprise (WBE) and Service-Disabled Veteran Owned Businesses (SDVOB) utilization. To support these objectives, the Project has implemented targeted resources, processes, and outreach efforts designed to expand access and opportunity. To date, the Project has awarded or committed over 324 contracts to certified MWBE and SDVOB firms. Of these, 193 are with businesses classified as Regional, defined in CBA Section 1.(n) as firms located within a 100-mile radius of Orchard Park, New York. 



PUBLIC ART PROGRAM

CBA Section 3.(1)(iii)

The Buffalo Bills announced the launch of a Public Art Program at new Highmark Stadium in February of 2025. The Bills' organization is committed to creating and expanding a public art program at new Highmark Stadium and dedicating resources to its growth and diversification. One way to achieve this objective is to create a permanent art presence at Highmark Stadium, which is scheduled to open in 2026, through the Buffalo Bills Public Art Program. The program will reflect the city's diverse demographics, team and fan engagement, and welcome travelers of all backgrounds to experience artwork in an inclusive environment

The Public Art Program seeks to commission professional visual artists, or artist teams, to create site-specific public artwork at new Highmark Stadium. This artwork will be thematic, public-facing, and part of the permanent collection at the stadium. Through an open Call for Artists Request for Qualifications (RFQ) and Request for Proposals (RFP) process, the Public Art Program will solicit applicants, review portfolios, and select qualified artists or artist teams who can innovatively and thoughtfully design within the context of the new stadium. Over three separate Calls for Artists, the Buffalo Bills Public Art Program will seek sculptural ceiling art, murals, and wall-based artworks of various sizes and budgets to be curated on all stadium levels.

The Buffalo Bills Public Art Program at new Highmark Stadium is dedicated to an equitable art procurement process. Calls for Artists within the stadium will follow national best practice standards for public art, receptive Q&A, transparent details, and public sharing, and allow opportunities for professional artists locally, regionally, and those with strong ties to Buffalo, at various skill levels and budget ranges.

The selected artworks will be installed ahead of the stadium's opening, following timelines that vary based on each piece's location and installation complexity.







LOOKING AHEAD

As part of its responsibilities in the Community Benefits Agreement (CBA), the Community Benefits Oversight Committee (CBOC) held its first public hearing on December 10, 2024, at the Frank E. Merriweather Jr. Library in Buffalo, NY. This hearing provided an opportunity to reflect on the achievements of the fiscal year 2023, gather community input, and discuss community priorities for the upcoming year.

Through public comments and discussion, the CBOC and Developer collaborated to identify community vulnerabilities and priorities, with a strong emphasis on supporting youth and young adults throughout Western New York. These Fiscal Year 2025 priorities include, but are not limited to: youth employment, job training for youth, youth apprenticeships, mentoring/life skills coaching for youth, financial literacy for youth, wrap around supports (including transportation, food, and housing) for youth, youth mental health, youth sports, after school programming, access to cultural spaces for youth, and any other opportunities for youth and young adults in the Region.

The progress made through the CBA to date reflects the dedication and collaboration of many partners across Western New York. We extend our sincere thanks to the State of New York, Governor Kathy Hochul, and Erie County Executive Mark Poloncarz for their leadership and continued support. We are also grateful to the National Football League and Commissioner Roger Goodell for their ongoing partnership and commitment to Western New York.

We recognize and applaud the front-line community leaders, players, coaches, and staff who pour their time, energy, and passion into building stronger, healthier communities. Most importantly, we thank the incredible people of Western New York for your trust, active participation, and for welcoming us into the heart of your community. Together, we are building a brighter future, one in which we all succeed.
