

Sweepstakes Official Rules

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (Entrant's) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.

3. Open to legal residents of the United States residing in New York State 18 years or older at time of entry (each eligible person to enter is an "Entrant").
