

**Sweepstakes Official Rules**  
**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

Purchase does not increase chance of winning.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Participation constitutes your (each eligible person to enter is an (“Entrant”)) full and unconditional agreement to and acceptance of these Official Rules. The information in Rule No. 2 outlines the specifics for this Sweepstakes.
2. **Name of Sweepstakes:** SnapDragon Apples (the “Sweepstakes”)  
**Sweepstakes Period:** 12:01am ET on December 17, 2024 and ends 11:59pm ET on December 20, 2024. (the “Sweepstakes Period”)  
**Drawing Dates:** On or around December 21, 2024.  
**Prize Description:** One (1) Greg Rousseau Signed Buffalo Bills jersey, eight (8) apples, autographed SnapDragon cards and hat.  
**Quantity and Value of Prizes to be Given Away:** One (1) Winner; approximate total retail value: \$200.  
**Sponsor(s):** Buffalo Bills, LLC, One Bills Drive, Orchard Park, NY 14127 (the “Bills”) and SnapDragon Apples, 53 Walnut St. Lockport, NY 14094 (collectively, the “Sponsor”)
3. **Open to legal residents of the United States residing in New York State eighteen (18) years or older at time of entry.** Employees of the Sponsor and its affiliates and subsidiaries; their advertising, promotion, and fulfillment agencies; and members of the immediate family or household of each of the above are not eligible to participate.
4. **HOW TO ENTER.** To enter, Entrant must follow the Sweepstakes instructions from the Buffalo Bills’ X account, (formally known as Twitter), retweet the designated post during the Sweepstakes Period stated in Rule No. 2. Limit one (1) entry per person, during the Sweepstakes Period. Multiple entries will not increase chances of winning and may result in your entry being filtered out. Enter using only a valid X account held by Entrant. All entries must be received by the Sweepstakes Period deadline stated in Rule No. 2. In the event of a dispute about entries submitted by multiple individuals using the same X account, entry will be deemed to have been submitted by the authorized holder of the X account used to enter the Sweepstakes at the actual time of entry. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. Entries containing offensive, obscene, derogatory, lewd, or other inappropriate content, as determined by the Bills in its sole discretion, are prohibited and will be disqualified. 5. **PRIZES AND ODDS OF WINNING.** One (1) winner will be selected by random on or around the drawing date stated in Rule No. 2. The Prize description and quantity of Prizes to be given away are stated in Rule No. 2. Prize consists of only those items specifically listed as part of the prize. The odds of winning a prize are dependent upon the number of entries. All prizes stated in Rule No. 2 will be awarded, assuming sufficient entries. The random drawing and awarding of prize(s) will be conducted under the supervision of the Buffalo Bills whose decisions are final and binding in all matters pertaining to the Sweepstakes. Entrant must abide by X Rules, and Entrants must ensure that their relevant social media account’s privacy settings are set to allow Buffalo Bills’ respective social media accounts to view the entry and communicate with the Entrant. If the reply is received within the deadline, the winner may be required to sign and return an Affidavit of Eligibility and Release of Publicity and Liability.
