## **BRONCOS FORD BRONCO ENTER TO WIN SWEEPSTAKES**

## **Official Rules**

**1. INTRODUCTION**: Denver Broncos Team, LLC, d/b/a the Denver Broncos Football Club (the "Broncos") and Ford Motor Company ("Ford" and, together with the Broncos, the "Sponsors") are offering a sweepstakes (the "Sweepstakes"). **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. PARTICIPATION IN THIS SWEEPSTAKES IS SUBJECT TO BINDING ARBITRATION FOR DISPUTE RESOLUTION.** 

**2. ELIGIBILITY:** Entrants must be U.S. residents 18 years of age or older excluding residents of the states of New York, Florida and Rhode Island. Employees of the Sponsors and the NFL Entities (as defined below) (collectively, the "Sweepstakes Entities"), their parents, subsidiaries, affiliated companies, and agents, dealers, advertising and promotional agencies, wholesale distributors and individual retail licensees and the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, are NOT eligible. 4. TO ENTER: Entrants must: visit https://www.denverbroncos.com/sponsors/ford/,fill out the registration form in its entirety and submit online to be eligible to win. Absolutely no entries will be accepted after the expiration of the Sweepstakes Period. Automated entries are prohibited and any use of automated devices will cause disqualification. Limit one entry per person/email address. Entrants may not enter with multiple email addresses nor use any other device or artifice to enter multiple times or as multiple entrants. Any entrant who attempts to enter with multiple email addresses under multiple unique identities or uses any device or artifice to register multiple times, as determined by Administrator in its sole discretion, will be disgualified and forfeits all prizes won Enter only using an e-mail address subscribed and registered in your name. **5. ODDS:** Odds of winning depend on number of eligible entries received. A group of five (5) finalists will be selected via a random drawing of all eligible entries on or about the Thursday immediately preceding the Denver Broncos' football team's last home game of the 2024 NFL season. An additional random drawing from among the finalists will occur on or around the date of the Denver Broncos' last home game of the NFL season to select the Grand Prize winner.

All drawings will be conducted the by Administrator, whose decisions are final in all matters relating to this Sweepstakes. Absolutely no assignment, transfer or substitution of the prize is permitted, except that the Sponsor may substitute a prize of equal or greater value. Limit one (1) prize per person.

**Winner Notification**: The finalists will be notified by telephone. Finalists must respond to such notification within 24 hours after notification or an alternate finalist will be selected from the remaining eligible entries. Once finalist accepts, they will be emailed information pertaining to the Grand Prize drawing.

Potential prize winners may be required to execute and return affidavits of eligibility and liability/publicity releases to the Administrator, except where prohibited by law, within five (5) days following the date of attempted notification. Subject to verification of eligibility and compliance with the terms of these Official Rules, including verification that the winner is eighteen (18) years of age or older, the potential winner will be declared an official winner of the Sweepstakes.
