

BRONCOS SWEEPSTAKES

Official Rules

1. **INTRODUCTION:** Denver Broncos Team, LLC d/b/a the Denver Broncos Football Club ("Broncos" or Sponsor) is offering a sweepstakes ("Sweepstakes"). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW. VOID WHERE PROHIBITED. PARTICIPATION IS SUBJECT TO BINDING ARBITRATION FOR DISPUTE RESOLUTION.

2. **ELIGIBILITY:** Entrants must be U.S. residents, and 18 years of age or older excluding residents of Florida, New York, and Rhode Island at the time of entry. Employees, contractors, directors, officers and agents of the Broncos, NFL Entities (as defined below), and Paramount+ ("Paramount+") (together, the "Sweepstakes Entities"), their parents, subsidiaries, affiliated companies, and agents, dealers, advertising and promotional agencies, wholesale distributors, individual retail licensees, all other service agencies involved with the Sweepstakes, the immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, and all those with whom such employees are domiciled, and all others associated with the development and execution of this Sweepstakes are NOT eligible to enter or win. 3. **TIMING:** Entire contest begins at 8:00:00 a.m. MDT on September 5, 2023 and ends at 11:59:00 p.m. MDT on October 1, 2023 ("Sweepstakes Period").

4. **TO ENTER:** Entrants must: visit <http://www.denverbroncos.com/ParamountPlus>, fill out the registration form in its entirety and submit online to be eligible to win. Absolutely no entries will be accepted after the cutoff deadline. Automated entries are prohibited and any use of automated devices will cause disqualification. Limit one sweepstakes entry per day per person/email address for the duration of the contest. Entrants may not enter with multiple email addresses nor use any other device or artifice to enter multiple times or as multiple entrants. Any entrant who attempts to enter with multiple email addresses under multiple identities or uses any device or artifice to register multiple times will be disqualified and forfeits all prizes won, in the Administrator's sole discretion. Enter only using an e-mail address subscribed and registered in your name. In the event of a dispute as to entries submitted by multiple individuals using the same e-mail account on the same day, entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter the sweepstakes at the actual time of entry and the authorized subscriber must comply with the Official Rules. 5. **PRIZES/ODDS:** Odds of winning will be one divided by the total number of eligible entries. One winner will be selected via a random drawing of all eligible entries on October 2, 2023.

Drawing will be conducted by Administrator whose decision is final in all matters relating to this Sweepstakes. No assignment, transfer or substitution of prize is permitted, except the Sponsor may substitute a prize of equal or greater value. Limit one (1) prize per person.

Winner Notification: The winners will be notified by telephone or email. Winners must respond to such notification within 24 hours after notification or an alternate winner will be selected from the remaining eligible entries. Once winner accepts prize, they will be emailed information pertaining to the prize. Any alternate potential winner selected will also be required to respond to the notification within the time frame stated above.

Potential Prize winners will be required to complete, sign, and return an Affidavit of Eligibility, Release of Liability and Publicity Release to the Administrator within three (3) days of prize acceptance. Subject to verification of eligibility and compliance with the terms of these Official Rules, including verification that the winner is eighteen (18) years of age or older, the potential winner will be declared an official winner of the Sweepstakes. If Sponsor cannot verify that the potential winner is eighteen (18) years of age or older prior to winner notification, then the potential winner will be disqualified and an alternate potential winner will be randomly selected (time permitting).

Eligible 2023 Denver Broncos home games to select from include: 10/8 New York Jets, 10/22 Green Bay Packers, 10/29 Kansas City Chiefs, 11/19 Minnesota Vikings, 11/26 Cleveland Browns, 12/24 New England Patriots, 12/31 Los Angeles Chargers. Each of the (10) ten runners up prize winners will receive: (1) one \$100 Denver Broncos team store gift card and free 1-year Paramount+ streaming. Prize package does not include taxes or any other items not specifically described in these Official Rules. If the winner cannot accept the prize as specified, prize will be forfeited and will be awarded to an alternate winner (time permitting). Prize is not redeemable for cash. Approximate retail value of grand prize is: \$1,710 and approximate value of runner up prize is \$160. Total approximate retail value of all prizes is \$1,870. DISPUTE RESOLUTION: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and the Sweepstakes Entities in connection with the Sweepstakes, or any claim or dispute that has arisen or may arise between you and the Sweepstakes Entities, shall be governed by, and construed in accordance with, the laws of the State of Colorado without giving effect to any choice of law or conflict of law rules. right to forward them to the AAA on the entrant's behalf, subject to ultimate allocation by the arbitrator. In addition, if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor retains the right to pay as much of the entrant filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (ix) If any part of this Arbitration Provision is deemed to be invalid or otherwise unenforceable or illegal, the balance of this Arbitration Provision shall remain in effect and shall be construed in accordance with its terms as if the invalid or illegal provision were not contained herein.
