

**ENTER TO WIN TICKETS TO FOO FIGHTERS  
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT  
INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The ENTER TO WIN TICKETS TO FOO FIGHTERS (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Persons under the age of eighteen (18) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of eighteen (18) may be automatically rejected and deleted. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required, and otherwise where prohibited or restricted by law, rule or regulation.

**PROMOTION PERIOD:** The Sweepstakes promotion period begins at 8:00 AM EST on February 25, 2026 and ends at 11:59 PM EST on February 28, 2026 (“Promotion Period”).

**Instagram:** To enter the Sweepstakes through Instagram you will need to be a registered user of Instagram. If you do not have an account you can open an Instagram account for free by registering with <http://instagram.com>. To enter this Sweepstakes via Instagram, you must like the post highlighting the Sweepstakes. If you choose to enter via Instagram using your mobile phone, standard data fees may apply. See your wireless provider for pricing plan details. Images must be in digital format. Only entries received via Instagram will be eligible. No print or film submissions will be accepted for entry into this Sweepstakes. All digital files must be 5 megabytes or smaller in JPEG or JPG format. The image need not be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable. By submitting your completed entry as directed during the Promotion Period, you will receive one (1) entry in the Sweepstakes.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. By submitting your completed entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes may be given the option to receive commercial e-mails from the NFL Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

**RANDOM DRAWING:** Potential winner(s) of the Sweepstakes (each a “Winner” and collectively, the “Winners”) will be selected by random drawing on or about the business day following February 28, 2026 from among all eligible entries received by the Sponsor during the Promotion Period . **The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Promotion Period .**

**PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS:** By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. **PRIZES AND APPROXIMATE RETAIL VALUE (“ARV”):** A total of one (1) prize(s) (each, a “Prize”), each of which is available to be awarded to one (1) winning entrant during the Promotion Period for a total of one (1) winning entrant(s). Each Prize includes: two (2) tickets to the Foo Fighters Concert on August 10, 2026 at Huntington Bank Field. The ARV of Prize is \$129.50 per winning entrant. Winner is fully responsible for any and all applicable federal, state,

and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided by Sponsor shall be borne by the Winner. All Prize details are at Sponsor's sole discretion.

The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

**NOTIFICATION:** The Winner will be notified by Sponsor either via e-mail, mail and/or telephone (as solely determined by Sponsor and/or the applicable NFL Entity, as applicable) by the Sponsor. In the event that any Winner does not respond to any such notification within three (3) days of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. The Winner may be required to submit his/her valid social security number (if applicable) and/or other identification to Sponsor and may be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance.
