

**2022 Season Ticket Waitlist Ticket Giveaway
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY PARTICIPATING IN THE SWEEPSTAKES, PARTICIPANT AGREES TO BE BOUND BY THE TERMS OF THESE OFFICIAL RULES, THE CLEVELAND BROWNS [PRIVACY POLICY](#) AND [TERMS OF USE](#), AND THE DECISIONS OF SPONSOR, WHICH SHALL BE FINAL IN ALL RESPECTS.

1. **Eligibility:** The 2022 Season Ticket Waitlist Ticket Giveaway (the “Sweepstakes”) is open to all legal residents of the United States who are eighteen (18) years of age or older as of the date of entry. Cleveland Browns Football Company LLC (“Sponsor”) is located at 76 Lou Groza Blvd., Berea, OH 44017. Employees of Released Parties and their immediate family members (parent, child, spouse or significant other, sibling and their respective spouses, regardless of where they reside) and/or household members (an individual resident in the same residence, whether or not related), are not eligible to enter or win. “Released Parties” as used herein shall mean Sponsor, Cleveland Browns Stadium Company LLC, the National Football League, its member professional football clubs and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies. All applicable federal, state and local laws apply. Void where prohibited. The Sweepstakes is in no way sponsored, endorsed, administered by or associated with Facebook, Twitter or any other social media platform.

2. **Entry Period:** Starts at 10:00:00 am Eastern Time (“ET”) on 08/18/2022 and ends at 4:59:59 pm ET on 01/31/2023 (“Entry Period”).

3. **How to Enter:** To receive one (1) entry to the Sweepstakes, you must either (i) be on the Cleveland Browns season ticket waitlist and have paid the waitlist deposit as of the Deadline for Entries specified in Section 5 below or (ii) mail to (1) postcard with proper postage affixed to Cleveland Browns, 76 Lou Groza Blvd., Berea, OH 44017, Attn: 2022 Waitlist Ticket Giveaway at least five (5) days prior to the applicable Deadline for Entries in Section 5 below. Any postcard(s) submitted must be legible and contain the following information: the entrant’s full name, address, phone and email (if any), and, if you want to opt-out of having your entry information used for sending you direct marketing unrelated to this Sweepstakes, write “MARKETING OPT-OUT” on the postcard. Each Official Entry Form must be received prior to the applicable Deadline for Entries to be eligible. **One (1) entry per person and per account will be accepted for the Sweepstakes.** Additional entries received from the same account or person in excess of the stated limitation will be void. In the event of a dispute as to the identity of an entrant, entry will be awarded to the account holder as listed on record with Sponsor, provided such individual is eligible according to these Official Rules. Released Parties are not responsible for late, lost, stolen, incomplete, illegible, inaccurate, misdirected, undelivered, damaged, or destroyed entries, and such entries may not be considered by Sponsor or Released Parties. No purchase or payment of any kind is necessary, and you need not consent to have your personal information used for direct marketing purposes unrelated to this Sweepstakes, to enter or win. A purchase and/or consenting to direct marketing will not increase your chance of winning. Winner Selection: For each Cleveland Browns home game at FirstEnergy Stadium at which full capacity audience is permitted to attend, one (1) Prize consisting of two (2) Club admission tickets will be awarded to one (1) potential winner (see also Section 5 below). Sponsor will contact all potential winners via phone or email, and each potential winner will have forty-eight (48) hours to claim the Prize. In the event the potential winner fails to claim the Prize by such deadline, an alternate winner will be selected. Odds of receiving a Prize will depend on the total number of eligible entries received prior to each applicable Deadline for Entries. Noncompliance with these Official Rules, a potential winner’s failure to respond within forty-eight (48) hours or Prize notification being returned as non-deliverable may result in disqualification and, time permitting, and at Sponsor’s sole discretion, an alternate winner may be selected. Prize winners will have been selected by 11:59:59 pm ET on the 10th day following the close of the Entry Period. **No more than two (2) tickets will be distributed to any one Entrant. An Entrant who is awarded tickets through the Sweepstakes is ineligible to receive an additional Prize via the Sweepstakes.**

5. Prize Package and Approximate Retail Value (“ARV”): Each of the following prizes will be awarded to one (1) winner, for a total of ten (10) unique winners, unless the Browns play a post-season game at FirstEnergy Stadium, in which case one (1) additional potential winner will be drawn for each such post-season home game. The total ARV of each Prize is approximately Two Hundred and Forty-Seven U.S. Dollars (\$247.00). All costs and expenses associated with the acceptance and use of a prize not specified herein as being awarded, including, but not limited to, travel expenses associated with redemption of a Prize and all federal, state and local taxes, are winner’s sole responsibility, and winners shall indemnify and hold the Released Parties harmless in all respects related thereto. All prize details are at the sole discretion of Sponsor and are subject to change. Prizes may not be sold, substituted for cash value, or transferred to any third party except as explicitly provided for in these Official Rules.
