## 2023 NextGen STM Giveaway Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. Note that any individual on the NextGen STM (Cleveland Browns season ticket waitlist) at the close of the Entry Period shall automatically receive one (1) Entry to the Sweepstakes. Any postcard(s) submitted must be legible and contain the following information: the entrant's full name, address, phone and email (if any), and, if you want to opt-out of having your entry information used for sending you direct marketing unrelated to this Sweepstakes, write "MARKETING OPT-OUT" on the postcard.
