

***Nationwide WPMOY Signed Football Repost to Win***  
**SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The Nationwide WPMOY Signed Football Repost to Win (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Persons under the age of eighteen (18) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of eighteen (18) may be automatically rejected and deleted. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, Nationwide, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required, and otherwise where prohibited or restricted by law, rule or regulation.

If you don’t already follow @browns on X, visit <https://x.com/browns> and click on the icon to follow @browns. Once you follow @browns, you must repost the post featuring a graphic with a photo of the signed football and the Walter Payton Man of the Year logo during the Promotion Period. Twitter's clock will be the official time keeper for this sweepstakes. If you make or receive tweets on your mobile phone, standard text messaging rates will apply. In order to participate in the Sweepstakes without receiving tweets on your mobile phone, be sure to deactivate your mobile phone from your Twitter account. Only one (1) entry per person or Twitter account will be accepted during the Promotion Period.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. By submitting your completed entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes may be given the option to receive commercial e-mails from the NFL Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

**PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS:** By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. Each Prize includes: one football autographed by Grant Delpit. The ARV of Prize is \$160.00 per winning entrant. Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and

withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided by Sponsor shall be borne by the Winner. All Prize details are at Sponsor's sole discretion.
