SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The Browns Italia Denzel Ward Jersey Giveaway (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Persons under the age of eighteen (18) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of eighteen (18) may be automatically rejected and deleted. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required, and otherwise where prohibited or restricted by law, rule or regulation.

PROMOTION PERIOD: The Sweepstakes promotion period begins at 9:00 AM EST on May 22, 2026 and ends at 9:00 AM EST on May 26, 2026 (“Promotion Period”).

Instagram: To enter the Sweepstakes through Instagram you will need to be a registered user of Instagram. If you do not have an account you can open an Instagram account for free by registering with <http://instagram.com>. To enter this Sweepstakes via Instagram, you must like the image featuring the signed Denzel jersey and follow @brownsitalia on Instagram. If you choose to enter via Instagram using your mobile phone, standard data fees may apply. See your wireless provider for pricing plan details. Images must be in digital format. Only entries received via Instagram will be eligible. No print or film submissions will be accepted for entry into this Sweepstakes. All digital files must be 5 megabytes or smaller in JPEG or JPG format. The image need not be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable. By submitting your completed entry as directed during the Promotion Period, you will receive one (1) entry in the Sweepstakes.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes may be given the option to receive commercial e-mails from the NFL Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

RANDOM DRAWING: Potential winner(s) of the Sweepstakes (each a “Winner” and collectively, the “Winners”) will be selected by random drawing on or about the business day following May 26, 2026 from among all eligible entries received by the Sponsor during the Promotion Period . **The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS: By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. Each Prize includes: 1 Browns jersey signed by Denzel Ward. The ARV of Prize is \$200.00 per winning entrant. Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and

withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided by Sponsor shall be borne by the Winner. All Prize details are at Sponsor's sole discretion.
