Newsome Football Giveaway Like-to-Win Sweepstakes

Official Rules

1. Eligibility: The Newsome Football Giveaway Like-to-Win Sweepstakes (the "Sweepstakes") is open to all legal residents residing in the United States who are 13 years of age or older as of date of entry. How to Enter: To enter the Sweepstakes, log-in to your Instagram account during the Entry Period and "Follow" the account @ClevelandBrowns and "like" the specified post from @ClevelandBrowns when prompted to receive one (1) official entry into the Sweepstakes (each, an "Official Entry"). You must have a valid and current Instagram account and follow @ClevelandBrowns to be considered eligible for the Sweepstakes. Each entry must be received by the close of the Entry Period to be eligible. Prizes. Potential winners will be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release prior and as a condition to receiving any prize.
