

## Nick Chubb signed jersey Like, Comment & Follow to Win Sweepstakes

### Official Rules

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. **1. Eligibility:** The Nick Chubb signed jersey Like, Comment & Follow to Win Sweepstakes (the “Sweepstakes”) is open to all legal residents of the [United States] who are [13] years of age or older as of the date of entry. Cleveland Browns Football Company LLC (“Sponsor”) is located at 76 Lou Groza Blvd., Berea, OH 44017. Employees of Released Parties and their immediate family members (parent, child, spouse or significant other, sibling and their respective spouses, regardless of where they reside) and/or household members (an individual resident in the same residence, whether or not related), are not eligible to enter or win. “Released Parties” as used herein shall mean, collectively, Sponsor, Cleveland Browns Stadium Company LLC, Instagram, the National Football League, its member professional football clubs and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies. All applicable federal, state and local laws apply. Void where prohibited. **2. Entry Period:** The “Entry Period” starts at 3:30 pm Eastern Time (“ET”) on 9.30.22 and ends at 7:00pm ET on 10.2.2022.

**3. How to Enter:** To receive one (1) entry for the Sweepstakes (each, an “Official Entry”), log-in to your Instagram account during the Entry Period and “Follow” the account @ClevelandBrowns and “like” the specified post from @ClevelandBrowns when prompted. You must have a valid and current Instagram account and follow @ClevelandBrowns to be considered eligible for the Sweepstakes. Each entry must be received by the close of the Entry Period to be eligible. Do not “tag” anyone in your comments or post any pictures with your comments. Entries that are deemed by the judges in their sole discretion to be immoral, obscene, or profane or not in keeping with Sponsor’s image or in violation of these Official Rules will be void. In addition, to be eligible, the Official Entry cannot include any third-party intellectual property or imagery. The Official Entry cannot defame or invade intellectual property rights of persons, living or deceased, or otherwise infringe upon any copyrighted, trademarked, or person’s personal or proprietary rights. In the event of a dispute as to the identity of an entrant, entry will be awarded to the person named on the Official Entry provided such individual is eligible according to these Official Rules. **Only one (1) entry per person and per Instagram account will be accepted during the Entry Period. All Official Entries must comply with the Instagram Terms of Use and Instagram Rules available at the Instagram Web Site. Creating multiple Instagram Accounts in order to exceed the limits on Official Entries permitted by these Official Rules may result in the disqualification of all Official Entries from such accounts. Important note: If your Instagram account is set to “protected mode,” your updates/responses may not be visible in Sponsor’s inbox and may be invalidated at Sponsor’s discretion.

No purchase or payment of any kind is necessary, and you need not consent to have your personal information used for direct marketing purposes unrelated to this Sweepstakes, to enter or win. A purchase and/or consenting to direct marketing will not increase your chance of winning. **4. Winner Selection:** For each prize listed below, [one (1)] potential Prize winner will be randomly selected from among all eligible Official Entries received during the Entry Period. The number of Prize winners selected during the Entry Period depends on the number of prizes offered. All Prize winners will be selected within 72 hours of the end of the Sweepstakes. Sponsor will contact the potential winner via phone, email, or through Instagram's direct message platform. Potential winner(s) will have seventy-two (72) hours to claim the prize. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive account(s), technical difficulties associated therewith, or an Entrant's failure to adequately monitor the platform of entry. In the event the potential winner fails to claim the prize by such deadline, an alternate winner may be selected. Odds of winning the Sweepstakes will depend on the total number of eligible entries received during the Entry Period and the number of Prizes. Potential winners may be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release prior and as a condition to receiving any prize. Noncompliance with these Official Rules, the inability of Sponsor to contact the potential winner within a reasonable time period or prize or prize notification being returned as non-deliverable may result in disqualification and, time permitting, and at Sponsor's sole discretion, an alternate winner being selected.

**5. Prizes:** The Prize is a Nick Chubb autographed replica jersey and has an approximate retail value of \$130 (without signature). The Prize will be awarded to [one (1)] Sweepstakes winner only. All costs and expenses associated with the acceptance and use of a prize not specified herein as being awarded, including, but not limited to, travel expenses (if any) associated with redemption of a prize and all federal, state and local taxes, are winner's sole responsibility, and winners shall indemnify and hold the Released Parties harmless in all respects related thereto. **6. Miscellaneous:** No transfer, assignment, cash redemption, or substitution of a prize (or any portion thereof) is permitted except by Sponsor which reserves the right to substitute a prize (or applicable portion thereof) with one of comparable or greater value, in its sole discretion if the prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The estimated value of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the estimated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Sponsor will not replace any lost or stolen prize items. By participating in the Sweepstakes, as permitted by applicable law and subject to [the Cleveland Browns Terms of Use](#), Entrant (the "Indemnifying Party") shall indemnify the Released
