

**ENTER TO WIN A SIGNED JERRY JEUDY FOOTBALL
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: The ENTER TO WIN A SIGNED JERRY JEUDY FOOTBALL (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Online Method: During the Promotion Period, go to <https://www.clevelandbrowns.com/tickets/expressaccess> and click on the banners, buttons and/or links to register for free for express access. Once registered, use the express access gates to enter the Cleveland Browns game on December 28, 2025.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void.
