OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: The 2025 SMS Mason Graham Autographed Jersey & Orange Replica Helmet Sweepstakes (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League, its member professional football clubs and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies (collectively, the “NFL Entities”), and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize.
