

Gregory Industries Football Repost to Win a Shedeur Signed Football
SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The Gregory Industries Repost to Win a Shedeur Signed Football(the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Persons under the age of eighteen (18) are not eligible to participate in this Sweepstakes under any circumstances. Any Entry received from a person under the age of eighteen (18) may be automatically rejected and deleted. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, Gregory Industries, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required, and otherwise where prohibited or restricted by law, rule or regulation.

PROMOTION PERIOD: The Sweepstakes promotion period begins at 5:30 PM EST on December 26, 2025 and ends at 9:00 AM EST on December 30, 2025 (“Promotion Period”).

X (formerly known as Twitter): To enter the Sweepstakes through Twitter, you must be a registered user of X or sign up for a free X account at www.X.com. If you don’t already follow @browns on X, visit <https://x.com/browns> and click on the icon to follow @browns. Once you follow @browns, you must repost the post featuring a graphic that includes a photo of the signed football prize during the Promotion Period. Twitter’s clock will be the official time keeper for this sweepstakes. If you make or receive tweets on your mobile phone, standard text messaging rates will apply. In order to participate in the Sweepstakes without receiving tweets on your mobile phone, be sure to deactivate your mobile phone from your Twitter account. Only one (1) entry per person or Twitter account will be accepted during the Promotion Period.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. By submitting your completed entry form and all other requested information as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes may be given the option to receive commercial e-mails from the NFL Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

RANDOM DRAWING: Potential winner(s) of the Sweepstakes (each a "Winner" and collectively, the "Winners") will be selected by random drawing on or about the business day following December 30, 2025 from among all eligible entries received by the Sponsor during the Promotion Period . **The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Each Prize includes: one (1) football signed by Shedeur Sanders. The ARV of Prize is \$300.00 per winning entrant. Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and

withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided by Sponsor shall be borne by the Winner. All Prize details are at Sponsor's sole discretion.

The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.
