ELIGIBILITY: The ENTER TO WIN A JOEL BITONIO MINI HELMET AND NJM DAWG HOUSE PRIZE PACK (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Dawg Tags: To enter the Sweepstakes, during the Promotion Period, scan the QR code found on the armrest of your seat in Huntington Bank Field and follow the instructions to complete and submit one (1) Official Entry Form. You must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. Each entry must be received during the Promotion Period to be eligible.

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void.
