Official Rules

- 1. Eligibility: The Myles Garrett Replica Jersey Giveaway Like-to-Win Sweepstakes (the "Sweepstakes") is open to all legal residents residing in the United States who are 13 years of age or older as of date of entry. Each entry must be received by the close of the Entry Period to be eligible. Important note: If your Threads account is set to "protected mode," your updates/responses may not be visible in Sponsor's inbox and may be invalidated at Sponsor's discretion.

The winner will be selected by a panel of judges determined by Sponsor in its sole discretion.
