

Myles Garrett Replica Jersey Giveaway Like-to-Win Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY PARTICIPATING IN THE BROWNS "LIKE" SWEEPSTAKES ("SWEEPSTAKES"), PARTICIPANT AGREES TO BE BOUND BY THESE OFFICIAL RULES, THE CLEVELAND BROWNS PRIVACY POLICY FOUND HERE, AND THE DECISIONS OF SPONSOR, WHICH SHALL BE FINAL IN ALL RESPECTS.

- 1. Eligibility:** The Myles Garrett Replica Jersey Giveaway Like-to-Win Sweepstakes (the "Sweepstakes") is open to all legal residents residing in the United States who are 13 years of age or older as of date of entry. Cleveland Browns Football Company LLC ("Sponsor") is located at 76 Lou Groza Blvd., Berea, OH 44017. Employees of Sponsor, Cleveland Browns Stadium Company LLC, Threads, the National Football League, its member professional football clubs and each of their respective parent, affiliates, subsidiaries and advertising and promotion agencies (collectively, "Released Parties") and their immediate family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and members of their households, whether or not related, are not eligible to enter or win. All applicable federal, state and local laws apply. Void where prohibited.
- 2. Entry Period:** The "Entry Period" starts at 2 p.m. Eastern Time ("ET") on July 27, 2023 and ends at 9 a.m. ET on July 31, 2023.
- 3. How to Enter:** To enter the Sweepstakes, log-in to your Threads account during the Entry Period and "Follow" the account @ClevelandBrowns and "like" the specified post from @ClevelandBrowns when prompted to receive one (1) official entry into the Sweepstakes (each, an "Official Entry"). You must have a valid and current Threads account and follow @ClevelandBrowns to be considered eligible for the Sweepstakes. Each entry must be received by the close of the Entry Period to be eligible. In the event of a dispute as to the identity of an entrant, entry will be awarded to the person named on the Official Entry provided such individual is eligible according to these Official Rules. (Note: You will need to create a Threads account if you don't already have one. Membership on Threads is free, and registration for Threads can be obtained by downloading the free Threads app and following the on-screen instructions). Only one (1) entry per person and per Threads account will be accepted during the Entry Period. Additional entries received from the same person or Threads account in excess of the stated limitation will be void. All entries must comply with the Threads Terms of Use and Threads Rules available on the Threads Application. Creating multiple Threads Accounts in order to exceed the limits on Entries permitted by these Official Rules may result in the disqualification of all Entries from such accounts. Important note: If your Threads account is set to "protected mode," your updates/responses may not be visible in Sponsor's inbox and may be invalidated at Sponsor's discretion.

- 4. Winner Selection:** [One (1)] potential Prize winner will be randomly selected from among all eligible entries received during the Entry Period for each Prize listed below. The number of Prize winners selected during the Entry Period depends on the number of prizes offered. All Prize winners will be selected by 9 a.m. ET on July 31, 2023. Sponsor will contact the potential winner via phone, email or through Instagram's direct message platform. The winner will be selected by a panel of judges determined by Sponsor in its sole discretion. Odds of winning the Sweepstakes will depend on the total number of eligible entries received during the Entry Period and the number of Prizes. Potential winners will be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release prior and as a condition to receiving any prize. Noncompliance with these Official Rules, the inability of Sponsor to contact the potential winner within a reasonable time period or prize or prize notification being returned as non-deliverable may result in disqualification and, time permitting, and at Sponsor's sole discretion, an alternate winner being selected.
