

2026 SMS DRAFT HELMET SWEEPSTAKES
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: The 2026 SMS Draft Helmet Sweepstakes (the “Sweepstakes”) is open to legal residents of the United States who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League, its member professional football clubs and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies (collectively, the “NFL Entities”), and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required, and otherwise where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: During the Promotion Period (defined below), an eligible entrant may enter by one (1) of the three (3) methods listed below:

- A. **Online Method:** During the Entry Period, go to (<https://browns.attn.tv/p/Bkr/landing-page>) or click on the banners, buttons and/or links to access the online entry form for the Sweepstakes entry page and register by following the prompts to complete the required fields on the entry page, such as name, email address, phone number, zip code, etc.
- B. **Text:** During the Promotion Period (defined below) text “**DRAFT26**” to short code **39709**. Your mobile phone must be capable of sending and receiving text messages to participate via this method. Standard text message rates apply. See your wireless provider for pricing plan details. All text message entries must be received by the end of the Promotion Period to be eligible. Entries generated by script, macro or other automated or mechanical means or with the intent to subvert the entry process are void. All entries become the property of Sponsor and will not be acknowledged or returned. By entering this Sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. Partial, incorrect or incomplete/piecemeal submissions WILL NOT BE ACCEPTED as Sweepstakes entries and shall not be eligible for any prize.

Mail-in entries must be postmarked during the Promotion Period and received by Sponsor within seven (7) calendar days following the end of each Entry Period(s) to be eligible. No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void.** All information and files submitted in the format specified will become property of Sponsor and used as provided in the applicable Terms of Use and Privacy Policy, each of which can be found by visiting <https://www.clevelandbrowns.com/about/terms-of-use> and <https://www.clevelandbrowns.com/about/privacy-policy> (both of which are incorporated herein by reference).

PROMOTION PERIOD: The Sweepstakes promotion period begins at 10:00 am ET on April 20, 2026, and ends at 11:59 pm ET on May 31, 2026 (“Promotion Period”).

RANDOM DRAWING: On or about the dates indicated in the chart above, the potential winner of the Sweepstakes (each a “Winner” and collectively, the “Winners”) will be selected by random drawing from among all eligible entries received by the Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS: By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. Entries cannot defame or invade the publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person's personal or property rights or any other third party rights. Sponsor reserves the right to require proof of these permissions in a form acceptable to Sponsor from any entrant at any time. Sponsor reserves the right to disqualify any entry it deems to be offensive, inappropriate, not in keeping with Sponsor's image or that is otherwise not in compliance with these Official Rules, in its sole discretion.

By entering the Sweepstakes, entrants agree to assign all right, title, and interest, including copyright rights, in the entry to Sponsor and grant permission for Sponsor, the NFL Entities and their respective designees to publish or publicize all or part of their entry, including but not limited to entrant's name, likeness and submission, in whole or in part, for advertising, promotional and

trade or other purposes in conjunction with this and similar promotions in any and all media now known or hereafter developed, worldwide in perpetuity, without notice or permission and without further compensation, except where prohibited by law.

PRIZES AND APPROXIMATE RETAIL VALUE (“ARV”): The Winner will receive the following prize: one (1) Browns Replica Helmet autographed by the 2026 Drafted Class. ARV: \$350. Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided by Sponsor shall be borne by the Winner, All Prize details are at Sponsor’s sole discretion.

The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor’s sole and absolute discretion. Sponsor reserves the right to substitute the Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

NOTIFICATION: The Winner will be notified by text message, e-mail, mail and/or telephone (in the sole discretion of Sponsor) by the Sponsor. In the event that any Winner does not respond to any such notification within three (3) days of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. The Winner may be required to submit his/her valid social security number (if applicable) and/or other identification to Sponsor and will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance. A disqualification will result, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate Winner may be randomly selected from among all remaining eligible entries if all required documents are not properly executed and returned within the specified period of time. The "Authorized Account Holder" is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address. Sponsor reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.
