SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The Dawgs in the Desert Sweepstakes (the “Sweepstakes”) is open to legal residents of the United States 21 years of age or older at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Cleveland Browns Football Company LLC (“Club”), the National Football League and, its member professional football clubs (collectively, the “NFL Entities”), and MGM Northfield Park and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. For avoidance of doubt, persons listed as voluntarily excluded patrons, involuntarily excluded patrons, or other banned patrons (as determined by MGM Northfield Park) are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the United States, states in which sweepstakes bonding is required if applicable, and otherwise where prohibited or restricted by law, rule or regulation.

PROMOTION PERIOD: The Sweepstakes promotion period begins at 12:00 AM EST on October 15, 2025 and ends at 11:59 PM EST on November 6, 2025 (“Promotion Period”).

HOW TO ENTER: During the Promotion Period, an eligible entrant may enter by the method(s) listed below:

No other method(s) of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, social media handle or Facebook login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. Entrants must fully complete and submit all non-optional data requested on the entry form to be eligible. Incomplete entries are void. Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

RANDOM DRAWING: Potential winner(s) of the Sweepstakes (each a "Winner" and collectively, the "Winners") will be selected by random drawing on or about the business day following November 6, 2025 from among all eligible entries, all criteria above must be met, and received by the Sponsor during the Promotion Period. **The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Promotion Period. Sponsor as used herein shall mean the Cleveland Browns as further described below.**

PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS: By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. Each Prize includes: Two (2) tickets to the Browns vs. Raiders game (the "Game") at Allegiant Stadium on Nov. 23, a three (3) night hotel stay from November 21-24 at Mandalay Bay Resorts and Casino (or other MGM Resorts International property in Las Vegas as determined by Sponsor) in a standard double occupancy room, and two (2) plane tickets to Las Vegas for the Game. All Prizing accommodations are determined by Sponsor in their sole discretion. The ARV of Prize is \$1,600.00 per winning entrant.
