ELIGIBILITY: The Sweepstakes is offered only to legal United States residents in the United States who are 21 years of age or older at the time of entry (each an "Eligible Entrant"). There will be (1) potential winner from all eligible entries for the Sweepstakes. If there are more than one correct or identical (potential) winning entries a winner will be selected at random from the (potential) correct entries.
