

**BUCS HIGH LOW SWEEPSTAKES
OFFICIAL RULES**

The Bucs High Low Sweepstakes (the “**Promotion**”) is sponsored by the Buccaneers Team LLC (the “**Sponsor**”). Promotion is offered only in the state of Florida (the “**Promotion Area**”). Void outside the Promotion Area and where prohibited.

INTRODUCTION

The Promotion consists of multiple weekly entry periods corresponding to select Tampa Bay Buccaneers 2026 regular season games, beginning with Week 1 and continuing through the end of the regular season (excluding the team’s Bye Week), for a total of seventeen (17) games (each, a “**Game**”). Each Game will have its own entry period (“**Game Period**”), as set forth in the Promotion Chart below. Only entries received during a valid Game Period will be eligible for the corresponding Game drawing. Entries submitted outside of an active Game Period will not be accepted. The Sponsor’s computer is the official time-keeping device for this Promotion.

Promotion is not sponsored, endorsed or administered by, or associated with the NFL Entities (below) or any of their respective parents, governors, subsidiaries, affiliates, directors, officers, shareholders or agents. The NFL Entities have neither offered, sponsored nor endorsed the Promotion. The NFL Entities will have no liability or responsibility for any claim arising in connection with participation in the Promotion or any prize awarded. By entering, accepting a prize and/or otherwise participating in this Promotion, you agree to completely release each of the NFL Entities from all liability. Autographed Merchandise

TO ENTER

As noted above, the Promotion is divided into seventeen (17) Game Periods. The dates are set out in the Promotion Chart below. Potential winners will be notified following the conclusion of each Game. **IT IS POSSIBLE THAT NOT ALL PRIZES OFFERED DURING THIS PROMOTION WILL BE AWARDED.** There are two (2) methods of entry: entry through the Buccaneers App and entry by email as described below. No other method of entry will be accepted.

Method 1: Entry Through the Buccaneers App. To enter through the Buccaneers App, you must have a compatible iOS or Android smartphone, tablet or other mobile device and data plan, and you must complete each of the following steps during an active Game Period:

Step 1 - Get the Buccaneers App: Download the free Buccaneers mobile application (the “**Buccaneers App**”) from the Google Play Store or Apple App Store if you have not done so previously. Your participation through the Buccaneers App will be subject to your agreement to, and compliance with, the applicable terms and conditions governing the use of the Buccaneers App.

Step 2 - Playing the High Low Game: Open the Buccaneers App and click on the “High Low” promotional graphic that appears near the top of the app’s home screen during an active Game Period. Follow the instructions to play the game, which will consist of three (3) to five (5) questions. For each question, you will be asked to guess whether a given value, fact, or statistic is higher or lower than the reference point provided.

Step 3 - Online Registration: After completing the game, you will be prompted to fill out the online registration form, including your full name, email address, phone number, and any other required information. You must also confirm that you have read and agree to these Official Rules and the Buccaneers Privacy Policy by checking the appropriate box. Once

submitted, your entry will be complete. Correct answers are not required to receive an entry, to be included in the random drawing, or to be eligible to win.

Method 2: Alternative Method of Entry by Email. To enter without downloading or using the Buccaneers App or playing the High Low game, during an active Game Period, send an email to sweepstakes@buccaneers.nfl.com with the subject line "Bucs High Low Sweepstakes Entry – [Game Period]" (e.g., "Game 1 (Bengals)") and include your full name, email address, phone number, date of birth, and Florida residential address in the body of the email. Email entries must be received during the applicable Game Period and before the close of that Game Period to be eligible for the corresponding Game Period drawing. Each Game Period opens on the date listed in the Promotion Chart below and closes at the conclusion of the Tampa Bay Buccaneers regular season game identified for that Game Period, after which no further entries for that Game Period will be accepted. After the close of each Game Period, the potential winner(s) for that Game Period will be selected in a random drawing from among all eligible entries received during that Game Period. Prizes will be awarded in the order of selection: the first name drawn will receive the first prize listed for that Game, and the second name drawn will receive the second prize listed for that Game. Each individual may only win one (1) prize per Game Period. Subject to verification of eligibility and compliance with these Official Rules, the selected individuals will be declared the winners of the corresponding prize. Sponsor reserves the right to award fewer than the stated number of prizes in any Game Period if it does not receive a sufficient number of eligible entries or if a selected winner is disqualified and there is insufficient time to select and verify an alternate.
