- 23. You must have a compatible iOS or Android smartphone, tablet or other mobile device with a data plan prior to September 10, 2023 to be eligible. To play, you must complete each of the following steps:
 - a. Step 1: Get the Bucs App: To participate, you must have a compatible smartphone or other wireless or mobile device and you must download (and if required, register an account on) the free official Tampa Bay Buccaneers mobile application (the "Bucs App"), from the Google Play Store (Android Market) or the Apple iTunes Store. Your participation in this Promotion will be subject to your agreement to, and compliance with, the applicable terms and conditions governing the use of the Bucs App.

Each Bingo Game will begin when the Bucs Game starts and end at the conclusion of the Bucs Game. To play, open the Bucs App on your compatible smartphone or other mobile device. Locate and activate the "Bucs Bingo presented by Coca-Cola®" feature.
