

## GUESS THE BUCS SCHEDULE

### CONTEST

#### Official Rules

**NO PURCHASE OR PAYMENT NECESSARY TO PLAY. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. THESE OFFICIAL RULES CONTAIN LANGUAGE THAT MAY LIMIT YOUR RIGHTS IN THE EVENT OF A DISPUTE, INCLUDING A MANDATORY ARBITRATION CLAUSE AND A CLASS ACTION WAIVER.**

The **GUESS THE BUCS SCHEDULE CONTEST** (the "Promotion") is sponsored by Buccaneers Team LLC, AdventHealth Training Center, One Buccaneer Place, Tampa, FL 33607 ("Sponsor").

**Timing:** The Promotion starts March 18, 2026, at 9:00 AM Eastern Time ("ET") and ends on April 30, 2026, at 11:59 PM ET (the "Entry Period"). Winners will be determined no later than June 1, 2026. Sponsor's computer is the Promotion's official clock. **DESPITE THE APRIL 30, 2026, ENTRY PERIOD DEADLINE, THE NATIONAL FOOTBALL LEAGUE 2026 SCHEDULE WILL NOT BE ANNOUNCED UNTIL EARLY TO MID-MAY.**

**Eligibility:** To participate in the Promotion, you must be at least twenty-one (21) years of age on the date of entry AND a resident of the United States. Void in the State of Rhode Island, the State of North Carolina, outside the United States, and where prohibited by law. Employees of Sponsor or its affiliates, parent companies, marketing agencies, Promotion vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Promotion and the immediate family members or those living in the same household of each are not eligible to participate.

**How to Enter the Promotion:** During the Entry Period, entrants must visit the official entry page (which may be accessed via the URL provided in promotional materials, including <https://buccaneers.rover.io/gLZlnk>) and complete all required information in its entirety. Entrants must predict the order (opponent and location) of the 2026 Tampa Bay Buccaneers regular season schedule (the "Schedule"), including the week of the Tampa Bay Buccaneers' bye week, and provide their first and last name, zip code, date of birth, and email address. Collectively, the schedule prediction and associated information constitute an "Entry." You do not need to sign up for the official Tampa Bay Buccaneers e-newsletter or SMS communications in order to submit an Entry. Limit of one (1) Entry per person. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason are void and will not be accepted. All Entries may only be submitted through the entry process available on <https://buccaneers.rover.io/gLZlnk>.

**Winner Selection:** After the conclusion of the Entry period, Sponsor or its designee will tabulate the number correct guesses (opponent and location and including the bye week) for each entrant for all eighteen (18) weeks based on the official 2026 NFL regular season schedule (released by the National Football League). (Only guesses that include correct opponent and location will be considered "accurate" for tabulation purposes). Subject to verification of eligibility and compliance with these Official Rules, the entrant with the highest number of correct guesses (i.e., correctly guesses both the opponent and location for the highest number of weeks), will be declared the "Grand Prize Winner" and the five (5) entrants with the next highest

number of correct guesses will be declared the "Second Prize Winners". Any tie between two (2) or more entrants for any prize will be broken using a random selection from among all tied entries.

**Prizes:** There will be one (1) Grand Prize Winner and five (5) Second Prize Winners in the Promotion.

The Grand Prize Winner will receive the following "Grand Prize:" Tickets for the Grand Prize Winner and one (1) guest (general upper-level reserved seating) to a Tampa Bay Buccaneers away game during the 2026 Regular Season (date to be determined by the Sponsor in its sole discretion), roundtrip (private charter flight) same-day airfare between Tampa International Airport and destination city, ground transfers in Tampa and destination city, and two (2) meals. **Grand Prize does not include any elements that are not expressly described above, including but not limited to transportation to and from Tampa and all lodging.** Total Grand Prize ARV: \$1,760.

Each Second Prize Winner will receive one (1) \$200 Tampa Bay Buccaneers gift card redeemable online at <https://shop.buccaneers.com/> (the "Second Prize"). Total Second Prize ARV: 2000.00.

Odds of winning the Grand Prize and the Second Prize depend upon the number of eligible entries received. The Grand Prize Winner and the Second Prize Winner will be notified by email.
