DRAFT DAY BUCS BINGO OFFICIAL RULES

THESE OFFICIAL RULES CONTAIN LANGUAGE THAT MAY LIMIT YOUR RIGHTS IN THE EVENT OF A DISPUTE, INCLUDING A MANDATORY ARBITRATION CLAUSE AND A CLASS ACTION WAIVER.

- 2. Game is subject to all federal, state and local laws. Sponsor shall be entitled to interpret these Official Rules as needed including but not limited to rules regarding Game plays, drawing entries, deadlines, winner selection, prize restrictions, and eligibility and all its decisions are final. Potential Field Goal Prize and Single Bingo Prize winners will be determined during the First Round of the 2025 NFL Draft on April 24, 2025. Entry deadline for Grand Prize Drawing (see below) is when the First Round of the 2025 NFL Draft ends (approximately 11:59 PM ET on the same night) immediately following the 32nd pick of the 2025 NFL Draft. Drawing to determine potential Grand Prize winner will be held on or about April 28, 2025. Sponsor's computer is the official time-keeping device for this Game.
- 4. For Game information and announcements, visit the Bucs Bingo feature on the Home tab in your Bucs App (see below) (the "<u>Game Tab</u>").
- 5. This Game is in no way sponsored, endorsed or administered by, or associated with, Apple, Inc. ("<u>Apple</u>") or Google, Inc. ("<u>Google</u>"). You are providing information to Sponsor and not to Apple or Google. The information you provide will only be used for administration of the Game and as otherwise set forth in these Official Rules. Any questions, comments or complaints that you have about this Game must be directed to Sponsor and not to Apple or Google. Personal data relating to participants are subject to Sponsor's Privacy Policy (see below)

ELIGIBILITY

- 6. All participants must be at least eighteen (18) years old and legal United States residents residing in the Game Area. You must have a compatible iOS or Android smartphone, tablet, or other mobile device with a data plan prior to the start of Draft Day to be eligible.

- 11. The odds of winning any prize depend on the number of participants in the Game, the number of Draft Events (as defined below) occurring during a Game, and the Draft Events on your randomized Game Board.

PRIZE RESTRICTIONS

- 12. **e-Gift Card Prize Restrictions**: e-Gift Cards are not valid in any physical location or any store other than the Bucs official online store, cannot be combined with any other special offers, sales, or discounts, and are subject to all terms and conditions thereon as well as any additional limitations or restrictions imposed by issuer. TO PLAY

- 17. **Step 1: Get the Bucs App**: In order to participate in the Game, you must have a smartphone or other compatible wireless or mobile device and you must download (and if required, register an account on) the free Buccaneers mobile application ("<u>Bucs App</u>"), from the Google Play Store (Android Market) or the Apple App Store (iOS). Your participation will be subject to your agreement to, and compliance with, the applicable terms and conditions governing the use of the Bucs App.
- 18. Game will begin on April 24, 2025, at 8:00 PM ET and end when the First Round of the 2025 NFL Draft ends (approximately 11:59 PM ET on the same night). To play, open the Bucs App on your compatible smartphone or other mobile device. Locate and select the Home Tab and then activate the "Bucs Bingo" feature.
- 19. **Step 2: Get Your Game Card:** Next, you will need to obtain a digital individual game card (a "<u>Game Card</u>"), which contains twenty-four (24) squares containing randomized Draft Events (defined below) and one (1) free square in the center that is considered automatically "covered" in all games.
- 20. While the Game status is "Open to Fans," you may either accept a randomly generated Game Card or you may customize your Game Card by choosing up to ten (10) draft events, which may include, but are not limited to, draftees selected, colleges represented and visual elements (collectively, "<u>Draft Events</u>"). To refresh your checkmarks, click the "sync" button on the setting tab at any time.

- 23. **Step 4: Submit Your Winning Pattern**: There are three (3) potential winning patterns or shapes (each a "<u>Winning Pattern</u>") that must be covered to be eligible to win a prize (or enter a drawing):
 - a. "Blackout" (all 25 squares covered);
 - b. "*Field Goal Post*" (the top three squares in the second and fourth vertical columns, the middle three (3) squares in the middle horizontal column (3rd row), and the last three (3) bottom squares in the middle vertical column (3rd row) must be covered to form the shape of a field goal post)); and
 - c. "*Single Bingo*" (five (5) consecutive covered squares in a straight line in any direction, i.e., horizontal, vertical or diagonal).
- 24. Once a Winning Pattern is completed on your Game Board, you <u>must</u> "<u>submit</u>" the pattern by pressing the button corresponding to that pattern, i.e., "Blackout," "Bingo" (for Single Bingo) or "Field Goal Post." Only players who <u>complete and submit</u> Winning Patterns will be eligible to win, as follows:
 - a. The first ten (10) players to <u>complete and submit</u> Single Bingo will be declared Single Bingo Prize winners. Additionally, each player to complete and submit a Single Bingo will be qualified to enter into the Grand Prize Drawing (see below); and
 - b. The first player to <u>complete and submit</u> Field Goal Post Bingo will be declared the Field Goal Post Prize winner. Additionally, each player to complete and submit a Field Goal Post Bingo will be qualified to enter into the Grand Prize Drawing (see below); and
 - c. Each player who <u>completes and submits</u> Blackout Bingo will be qualified to enter the Grand Prize Drawing (see below).
- 25. **Step 5: Grand Prize Drawing**: Each player who <u>completes and submits</u> a Single Bingo, Field Goal Post Bingo, or Blackout will receive a notification message with an entry link to enter the Grand Prize Drawing (for a potential of up to 3 entries in the Grand Prize drawing). Simply click through the link in the Single Bingo, Field Goal Post Bingo, and Blackout notification message on the Bucs App and complete an official entry form with all required information, which may include your name, phone number, and "win code" no later than 11:59 PM ET on April 24, 2025. Proof of sending is not proof of receipt by Sponsor. Sponsor will not accept screen shots as proof of entry. **Entry is not automatic; you must complete the entry form to be entered in the Grand Prize drawing**.

GRAND PRIZE DRAWING

30. On April 28, 2025, or within a reasonable time thereafter, Sponsor or its designee will randomly choose one (1) name from all timely entries received in the Grand Prize Drawing. Subject to verification of eligibility, the person whose name is so drawn will be declared the Grand Prize winner.

NOTIFICATION OF WINNERS

31. Single Bingo Prize Winners and Field Goal Post Prize Winners: Single Bingo and Field Goal Post winners will instantly receive a popup notification message in the Bucs App with a link to redeem their applicable prize(s) (the "Redemption Link"). If you receive a prize notification message with a Redemption Link, you must click through the Redemption Link and complete the form with all required information, which may include your name, phone number, and "win code," before the Redemption Link expires. Each Redemption Link will only be valid for approximately twelve (12) hours after the end of the Game. If any potential Single Bingo or Field Goal Post winner does not redeem his/her prize prior to its expiration date, that Single Bingo Prize or Field Goal Post Prize will be forfeited by that winner. Sponsor reserves the right to cancel, suspend or terminate this Game, or any part thereof, if Sponsor determines, in its sole discretion, that the security, administration, fairness and/or operation of the Game has been corrupted or impaired by any non-authorized intervention, network failure, information storage failure, telecommunications failure, malfunction, or any other cause beyond Sponsor's control. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the participants or Released Parties in connection with the Game, shall be governed by Florida law, without giving effect to any choice of law rules that would cause the application of the laws of any jurisdiction other than Florida.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE ENTRY PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
- 49. In the event of any discrepancy or inconsistency between any terms or conditions of these Official Rules and any disclosures or other statements contained in any other Gamerelated materials, including but not limited to the Game content or entry forms, or point of sale, television, print, mobile or online advertising, the terms and conditions of these

Official Rules shall prevail, govern and control. If any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
