## **Official Rules**

**Timing**: The Promotion starts March 27, 2023, at 8:00 AM Eastern Time ("ET") and ends on April 30, 2023, at 11:59PM ET (the "Entry Period"). Sponsor's computer is the Promotion's official clock. **DESPITE THE APRIL 30, 2023 ENTRY PERIOD DEADLINE, THE NATIONAL FOOTBALL LEAGUE 2023 SCHEDULE WILL NOT BE ANNOUNCED UNTIL EARLY TO MID-MAY**. In the unlikely event that the NFL releases the 2023 Schedule before the conclusion of the Entry Period, the Entry Period shall conclude at 11:59PM ET five (5) calendar days prior to the official 2023 NFL Schedule release.

**Eligibility**: To participate in the Promotion, you must be at least twenty-one (21) years of age on the date of entry AND a resident of the continental United States. Void in the State of Rhode Island, outside the continental United States, and where prohibited by law. Collectively the 2023 Tampa Bay Buccaneers regular season prediction and associated information are your "Entry". You do not need to sign up for the official Tampa Bay Buccaneers e-newsletter in order to submit an Entry. Limit of one (1) Entry per person. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason are void and will not be accepted. All Entries may only be submitted through the entry process available on https://buccaneers.rover.io/P93kBU.

**Winner Selection**: Based on the official 2023 NFL regular season schedule (released by the National Football League), the entrant who most accurately predicts the correct order of opponents (including the bye week) for all eighteen (18) weeks (i.e., guesses the opponent/location for the highest number of correct weeks), will be selected as the "Grand Prize Winner". If there is a tie between two (2) or more entrants, then the Grand Prize Winner will be randomly selected from among all tied entries.

In addition, Sponsor will randomly select a total of ten (10) participation prize winners ("Participation Prize Winners") from all timely entries received.
