50/50 RAFFLE PROMOTION -
OFFICIAL RULES**

1. **NO CONTRIBUTION OR PURCHASE NECESSARY TO ENTER OR WIN. A CONTRIBUTION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The August 26, 2023 Tampa Bay Buccaneers Foundation 50/50 Raffle Promotion (the "**Promotion**") is sponsored by the Tampa Bay Buccaneers Foundation, Inc. (the "**Foundation**"), a Section 501(c)(3) tax-exempt organization with its principal place of business at AdventHealth Training Center, One Buccaneer Place, Tampa, Florida 33607. The Foundation is the official charity of the Tampa Bay Buccaneers Football club (the "**Buccaneers**"). Promotion is only offered in the state of Florida (the "**Promotion Area**"). Void outside the Promotion Area and where prohibited.
2. The Promotion raises funds to support the Foundation's mission of uplifting our community, inspiring our youth and driving social change through programs that enrich the lives of families in our region. Prize is funded by the Foundation or donated by the Buccaneers. No refunds will be made, except as otherwise determined by the Foundation in its sole discretion. Raffle ticket (each a "**Raffle Ticket**") purchases are not tax deductible. Making a contribution or donation will not improve your chances of winning.
3. Promotion is subject to all federal, state and local laws. The Foundation shall be entitled to interpret these Official Rules as needed — including but not limited to rules regarding Raffle Tickets, deadlines, [Winning Ticket Number](#) (defined below) selection, prize restrictions, and eligibility — and all its decisions are final. By participating, you irrevocably, fully and unconditionally agree to be bound by these Official Rules and waive any right to claim ambiguity in these Official Rules and or any other Promotion-related advertising or materials.
4. Promotion begins on August 21, 2023 at 8:00:00 AM Eastern Time ("**ET**"). Raffle Tickets will be available online throughout the [Promotion Period \(defined below\)](#). Raffle Tickets will also be available during the Buccaneers home game at Raymond James Stadium (the "**Stadium**") on August 26, 2023 (the "**Bucs Game**") beginning when public parking lots at the Stadium open for the Bucs Game. Raffle Tickets are only valid for the drawing to be held on August 26, 2023.
5. Final deadline to obtain or request [Raffle Tickets](#) is the end of the Bucs Game on August 26, 2023. Drawing to determine the winning Raffle Ticket number (the "**Winning Ticket Number**") will be held on August 26, 2023 at the end of the Bucs Game or within a reasonable time thereafter. You do not have to be present to win. Stadium scoreboard will be the official time-keeping device for the Promotion.
6. Please note that National Football League ("**NFL**") game dates and times and gate opening times are determined in the sole discretion of the NFL and/or the [Buccaneers](#), as applicable, and are subject to change. If the [Bucs Game](#) is not played for any reason, the Promotion will not be held. For Promotion information and announcements, visit <http://www.buccaneers.com/5050> (the "**Promotion Page**").
7. **Winner will be issued an IRS 1099 MISC tax form (or its equivalent or other required documentation and/or reporting forms) for the ARV of the prize awarded if required and is solely and exclusively responsible for all state, federal or local income taxes**

that may result from his or her acceptance of the prize. The Foundation is required by law to withhold and remit to the Internal Revenue Service on the winner's behalf an amount equal to twenty-five percent (25%) of the prize awarded (such amount being referred to herein as the "Withholding Amount") if the value of the prize exceeds \$5,000 and the winner is a citizen or resident alien of the United States with a Social Security number (different rules as promulgated by the Internal Revenue Service apply for nonresident aliens and for resident aliens and citizens of the United States who do not have a Social Security number) or as otherwise required by law.

ELIGIBILITY

8. To be eligible, each entrant must be at least eighteen (18) years old and a legal resident of the United States (as defined by the Internal Revenue Service ("IRS")) present in the Promotion Area (above) at the time of entry.
9. Employees, officers, directors, agents, and representatives of the [Foundation](#), Buccaneers Team LLC ("**BTLLC**"), the [Buccaneers](#), any other entity directly involved in the development or administration of the Promotion, and the members of their immediate families (defined as spouses, parents, siblings, and children, and each of their respective spouses) and households, are not eligible to enter or win. The term "**household**" includes all persons residing together (part-time or full-time) in a single residence, whether or not related.

PRIZE, ODDS & RESTRICTIONS

10. Prize (1): Cash or check in the amount of Fifty Dollars (\$50.00) or fifty percent (50%) of the Net Raffle Proceeds, whichever is greater. "**Net Raffle Proceeds**" shall mean the total Raffle Proceeds collected through Raffle Ticket donations during the Promotion less sixteen percent (16%) to cover royalties, staffing, and other equipment-related costs. The actual amount received by the winner shall be subject to and reduced by the [Withholding Amount \(as defined above\)](#) if any. Approximate Retail Value ("**ARV**"): minimum of \$50. Foundation's computer (or the computer of its third-party administrator) shall be the Promotion's official count of total raffle proceeds.
11. All prize details shall be at the Foundation's sole discretion. The winner assumes sole responsibility for all expenses and incidental costs associated with the prize not explicitly outlined above, including without limitation, all federal, state and local taxes (if any), surcharges, and fees. Any person who wins prizes through any Foundation-sponsored promotions with a cumulative [ARV](#) equal to or greater than \$600 in a calendar year will receive an IRS 1099 Form and/or other appropriate tax document.
12. The right to receive the prize is not transferrable. Prize or portion thereof not accepted by the winner is forfeited and no cash or substitute will be offered or permitted, unless required by law. The prize may not be substituted except that the Foundation in its discretion may substitute a prize, or portion thereof, with a prize or portion of equal or greater value if it deems necessary. Any such changes will be announced. Other restrictions apply.

TO PARTICIPATE

13. [Raffle Tickets](#) will be available beginning August 21, 2023 at 8:00:00 AM ET and ending at the conclusion of the [Bucs Game](#) on August 26, 2023 (the "**Promotion Period**"). Raffle Tickets may be obtained online throughout the Promotion Period. Raffle Tickets will also be available at the Bucs Game on August 26, 2023. To obtain Raffle Tickets:
- a. **Online Sales:** Raffle Tickets will be available to purchase online by visiting <http://www.buccaneers.com/5050> throughout the Promotion Period (see below for [Suggested Minimum Contribution](#));
 - b. **In-Person at Kiosks:** Starting at approximately ninety (90) minutes before kick-off on the day of the [Bucs Game](#), Raffle Tickets may be available at up to eight (8) stationary selling locations on the concourses at the [Stadium](#) ("**Kiosks**"), in the following Sections: Section 211 – West Club; Section 234 – East Club; Section 106 – Lower West Concourse; Section 115 – Lower West Concourse; Section 131 – Lower East Concourse; Section 140 – Lower East Concourse; Section 310 – Upper West Concourse; Section 333 – Upper East Concourse (see below for [Suggested Minimum Contribution](#));
 - c. **In-Stadium Raffle Sales Representatives:** Starting at approximately ninety (90) minutes before kick-off on the day of the Bucs Game, Raffle Tickets will be available throughout the Stadium from uniformed Raffle Sales Representatives (see below for [Suggested Minimum Contribution](#));

"Suggested Minimum Contribution" for Raffle Tickets is as follows:

- For Raffle Tickets purchased between the start of the Promotion Period (August 21, 2023 at 8:00:00 AM) through August 25 (ending at 11:59:59 PM): \$10 for (10) Raffle Tickets, \$20 for forty (40) Raffle Tickets, \$40 for two hundred (200) Raffle Tickets, and \$100 for eight hundred (800) Raffle Tickets;
 - For Raffle Tickets purchased on the day of the Bucs Game (beginning at 12:00:00 AM) through the conclusion of the Promotion Period (end of the Bucs Game): \$10 for five (5) Raffle Tickets, \$20 for twenty (20) Raffle Tickets, \$40 for one hundred (100) Raffle Tickets, and \$100 for four hundred (400) Raffle Tickets; or
- d. **NO CONTRIBUTION OR PURCHASE NECESSARY:** You may obtain [Raffle Tickets](#) without making a purchase or contribution by completing and submitting an official raffle form available [here](#). Additionally, if you are inside the Stadium you may visit the Stadium Kiosk in the Upper East Concourse near Section 333 during the [Promotion Period](#). A request for and receipt of a [Raffle Ticket](#) constitutes your full and unconditional agreement to and acceptance of these Official Rules, including all entry requirements.

These are the only methods of obtaining Raffle Tickets. Raffle Tickets will not be distributed via U.S. mail or any method other than described above. DATA CHARGES MAY APPLY TO USE OF MOBILE PHONE/DEVICE TO PARTICIPATE IN THE PROMOTION.

14. **Regardless of method, [Raffle Tickets](#) will only be distributed as described above and until the end of the [Bucs Game](#) on August 26, 2023. **Non-winning Raffle Tickets are not valid for subsequent Promotions, if any.****
15. The Foundation is not responsible for Raffle Tickets that are lost, misdirected, garbled, distorted, truncated, incomplete, illegible, damaged, defaced, altered, tampered with, counterfeit, unauthenticated, copied or incorrect for any reason, and all such Raffle Tickets are void. The Foundation reserves the right in its sole discretion to disqualify any Raffle Ticket at any time that in its opinion does not comply with these Official Rules.

WINNING TICKET SELECTION & ANNOUNCEMENT; WINNER VERIFICATION

16. Following the [Bucs Game](#) on August 26, 2023, or within a reasonable time thereafter, the Foundation or its designee will randomly choose one (1) [Winning Ticket Number](#) from all Raffle Tickets timely distributed during the Promotion. The Winning Ticket Number will be published to the [Promotion Page](#) within twenty-four (24) hours of the drawing. Subject to verification of eligibility, the person who presents the Raffle Ticket with the matching Winning Ticket Number (the "**Winning Raffle Ticket**") during the [Claims Period \(defined below\)](#) will be declared the winner. **You do not have to be present to win.**
17. To claim the prize, the winner must email communityrelations@buccaneers.nfl.com stating they have the Winning Raffle Ticket and complete the verification process as designated by the Foundation within sixty (60) calendar days of the Bucs Game (the "**Claims Period**").
18. The original Winning Raffle Ticket is the only valid receipt for claiming the prize. A Foundation representative will provide further instructions on how to present the Winning Raffle Ticket for verification and present and/or execute the [Verification Requirements](#) (as described below). The [Released Parties](#) (as defined below) are not responsible for lost or stolen Raffle Tickets or Raffle Tickets redeemed in error by their agents. For questions or inquiries, please call a Foundation representative at (813) 870-2700 during regular business hours Monday through Friday.

Verification Requirements

19. The potential winner may be required, no later than the end of the [Claims Period](#), to provide the Foundation with his/her mailing address ("**Mailing Address**"), telephone number, signed or executed Affidavit or Declaration of Eligibility and Liability/Publicity Release, two (2) forms of identification satisfying the requirements for completion of the W-9 tax document, including - or as well as - at least one (1) valid government-issued photo identification, and a completed W-9 tax form.
20. Upon presentation of the [Winning Raffle Ticket](#) during the [Claims Period](#), the Foundation will verify that such Raffle Ticket bears the [Winning Ticket Number](#) and is the authentic Winning Raffle Ticket and thereafter may require to retain the Winning Raffle Ticket. Within thirty (30) days of the winner's compliance with the foregoing verification requirements and procedures, the Foundation shall mail a check in payment of the prize, less the [Withholding Amount](#), if any, to the winner at his/her [Mailing Address](#).

21. If the potential winner fails to timely present the Winning Raffle Ticket, fails to timely and completely satisfy any eligibility or verification requirement herein, declines to accept the prize, or is otherwise determined to be ineligible, the Foundation in its discretion may disqualify that individual and he/she will forfeit the prize. If the Winning Raffle Ticket otherwise is not presented to the Foundation prior to the end of the Claims Period and in accordance with the procedures above, the prize will be forfeited. If forfeited, the prize will be retained by the Foundation.
22. The Foundation will not be required to attempt to notify or locate the holder of the [Winning Raffle Ticket](#) in any manner other than by publishing the [Winning Ticket Number](#) on the [Promotion Page](#) as noted above. [Released Parties \(as defined below\)](#) will not be responsible for the failure of any person to review the Promotion Page for the Winning Ticket Number or to call the Foundation's telephone number at (813) 870-2700, or for otherwise being unaware that he or she may possess the Winning Raffle Ticket, or for failing present the Winning Raffle Ticket during the Claims Period and otherwise as required by these Official Rules. Any purported Winning Raffle Ticket not presented to the Foundation during the Claims Period and in accordance with these Official Rules shall be void and the prize forfeited. If forfeited, the prize will be retained by the Foundation.

The Foundation and [BTLLC](#) may, in their sole discretion, post the verified winner's name on the Promotion Page and/or any of the Foundation's and BTLLC's respective websites, including <http://www.buccaneers.com>, and any of the Foundation's and BTLLC's respective social media pages or channels, and broadcast it on any of the Foundation's and BTLLC's respective stations.

PUBLICITY RELEASE

24. By accepting a prize, the winner agrees to award the Foundation and BTLLC the right to publicize his or her name, photograph (including the use and appearance of his or her photograph on the Foundation's and BTLLC's respective websites), likeness, biographical information, e-mail address, voice and details of winning for purposes of this and future promotions without further compensation, except where prohibited.

MISCELLANEOUS

30. The Foundation reserves the right to cancel, suspend or terminate this Promotion, or any part thereof, if the Foundation determines, in its sole discretion, that the security, administration, fairness and/or operation of the Promotion has been corrupted or impaired by any non-authorized intervention, network failure, information storage failure, telecommunications failure, malfunction, or any other cause beyond the Foundation's control. In such an event, the Foundation will post notice of same at the [Promotion Page](#) and select the [Winning Ticket Number](#) at random from all non-suspect [Raffle Tickets](#) distributed prior to the suspension, cancellation or termination of the Promotion.
31. The Foundation reserves the right to disqualify any individual from further participation in the Promotion if the Foundation concludes, in its sole discretion, that such person (a) has attempted to tamper with the operation of the Promotion or any Raffle Ticket in any way, (b) has repeatedly disregarded or has attempted to circumvent these Official Rules, or (c) has acted towards the Foundation or any other entrant or other participant in an unfair, inequitable, deliberately annoying, threatening, disrupting or harassing manner. Tampering includes using or attempting to use any prohibited device or Raffle Ticket or method of entry. Any failure by the Foundation to enforce any of these Official Rules shall not constitute a waiver of such Official Rules.
32. All activity arising out of and relating to the Promotion, including any reference to the status of any person as the "winner" or any [Raffle Ticket](#) as the "[Winning Raffle Ticket](#)" is subject to verification and/or auditing for compliance with the Official Rules. If the Foundation determines, in its sole discretion, that verification or auditing activity evidences non-compliance of a Raffle Ticket and/or entrant with the Official Rules, the Foundation reserves the right to disqualify such Raffle Ticket and/or entrant from the Promotion and the prize at any time. The Foundation reserves the right to conduct a background check on the potential winner and to disqualify such individual based on such background check if the Foundation determines in its sole discretion that awarding a prize to such individual might reflect negatively on the Foundation or [BTLLC](#). Each entrant agrees to cooperate

with the Foundation and its representatives in connection with all verification, auditing and/or background check activities.

34. The Foundation reserves the right to correct typographical, printing or clerical errors in any Promotion-related materials. No more than the stated number of prizes will be awarded. If production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, the Foundation reserves the right to award only the stated number of prizes by a random drawing from among all legitimate, un-awarded, eligible prize claims.

DISPUTES

35. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrants or other participants or [Released Parties](#) in connection with the Promotion, shall be governed by Florida law, without giving effect to any choice of law rules that would cause the application of the laws of any jurisdiction other than Florida.
36. **Arbitration:** Except where prohibited by law, by participating in the Promotion, you expressly agree that (a) all disputes and causes of action arising out of or connected with this Promotion, or the prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration administered by JAMS with a panel of three (3) arbitrators under its Comprehensive Arbitration Rules; (b) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (c) judgment upon such arbitration award may be entered in any court having jurisdiction. Such arbitration shall adhere to JAMS's Minimum Standards for Arbitration Procedures, remain confidential, and be held in Tampa, Florida.
37. By participating in the Promotion, you expressly (a) agree that any legal proceedings arising out of or relating in any way to this Promotion or these Official Rules and not subject to arbitration shall be brought only in the federal or state courts located in Hillsborough County, Florida, and (b) consent to the mandatory and exclusive jurisdiction in such courts with respect to any such legal proceedings.
38. In the event of any discrepancy or inconsistency between any terms or conditions of these Official Rules and any disclosures or other statements contained in any other Promotion-related materials, including but not limited to the [Raffle Tickets](#) or receipts, or point of sale, television, print, mobile or online advertising, the terms and conditions of these Official Rules shall prevail, govern and control. If any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

39. Any third-party trademarks mentioned herein are the property of their respective trademark owners. The use or mention of such third-party trademarks in these Official

Rules or in the Promotion is solely for descriptive purposes and shall in no way imply an endorsement or sponsorship of the Promotion.
