Collectively the 2025 Tampa Bay Buccaneers regular season prediction and associated information are your "Entry". You do not need to sign up for the official Tampa Bay Buccaneers e-newsletter or SMS communications in order to submit an Entry. Limit of one (1) Entry per person. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason are void and will not be accepted. All Entries may only be submitted through the entry process available on https://bccn.rs/guesstheschedule2025.

Winner Selection: After the conclusion of the Entry period, Sponsor or its designee will tabulate the number correct guesses (opponent <u>and</u> location and including the bye week) for each entrant for all eighteen (18) weeks based on the official 2025 NFL regular season schedule (released by the National Football League).
