

# 2020 TAMPA BAY BUCS KICKOFF SWEEPSTAKES IN ASSOCIATION WITH THE INVISALIGN BRAND

## OFFICIAL RULES

MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

**1. Eligibility: 2020 Tampa Bay Bucs Kickoff Sweepstakes in association with the Invisalign brand** ("Sweepstakes") is open only to legal residents of Florida, age 18 or older at the time of entry. **3. TO ENTER: INTERNET:** Visit [https://buccaneers.formstack.com/forms/invisalign\\_sweeps\\_2020](https://buccaneers.formstack.com/forms/invisalign_sweeps_2020) and follow the on-screen instructions to properly complete and submit an online entry.

Only entries received during the Sweepstakes Entry Periods and which are otherwise fully compliant with these Official Rules are "Valid Entries." Limit one (1) entry per person, per wireless phone number, per e-mail address per day, regardless of method of entry stated above. A "day" is defined as 12:00:01 a.m. Eastern Standard Time through 11:59:59 p.m. Eastern Standard Time.
