TAMPA BAY BUCCANEERS FOUNDATION 2023 NFL DRAFT 50/50 RAFFLE OFFICIAL RULES

- NO CONTRIBUTION OR PURCHASE NECESSARY TO ENTER OR WIN. A CONTRIBUTION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Tampa Bay Buccaneers Foundation Draft Night 50-50 Raffle (the "<u>Raffle</u>") is sponsored by Tampa Bay Buccaneers Foundation, Inc. (the "<u>Foundation</u>"), a Section 501(c)(3) tax-exempt organization with its principal place of business at One Buccaneer Place, Tampa, FL 33607. The Foundation is the official charity of the Tampa Bay Buccaneers Football club (the "<u>Buccaneers</u>"). Raffle is only offered in the state of Florida (the "<u>Raffle Area</u>"). Void outside the Raffle Area and where prohibited.
- 2. The Raffle raises funds to support the Foundation's mission of uplifting our community, inspiring our youth and driving social change through programs that enrich the lives of families in our region. Prize is funded by the Foundation or donated by the Buccaneers. No refunds will be made, except as otherwise determined by the Foundation in its sole discretion. Raffle ticket (each a "<u>Raffle Ticket</u>") purchases are not tax deductible. Making a contribution or donation will not improve your chances of winning.
- 3. The Raffle is subject to all federal, state and local laws. The Foundation shall be entitled to interpret these Official Rules as needed including but not limited to rules regarding Raffle Tickets, deadlines, winning ticket number selection(s), prize restrictions, and eligibility and all its decisions are final. By participating, you irrevocably, fully and unconditionally agree to be bound by these Official Rules and waive any right to claim ambiguity in these Official Rules and or any other Raffle-related advertising or materials.
- 4. The Raffle begins on April 24, 2023 at 12:00 PM Eastern Time ("ET"). Raffle Tickets will be available online throughout the Promotion Period (defined below). Raffle Tickets will also be available during the 2023 NFL Draft Celebration (the "Draft Celebration") at Raymond James Stadium (the "Stadium") on April 27, 2023 starting at 7:00 PM ET and ending at 10:30 PM ET. Final deadline to obtain or request Raffle Tickets is April 29, 2023 at the end of the 2023 NFL Draft. The Foundation's computer will be the official time-keeping device for the Raffle.
- 5. For Raffle information and announcements, visit <u>http://www.buccaneers.com/5050</u> (the "<u>Raffle Page</u>").
- 6. Winner will be issued Internal Revenue Service ("<u>IRS</u>") 1099 MISC tax form (or its equivalent or other required documentation and/or reporting forms) for the ARV of the prize awarded if required and is solely and exclusively responsible for all state, federal or local income taxes that may result from his or her acceptance of the prize(s). The Foundation is required by law to withhold and remit to the Internal Revenue Service on the winner's behalf an amount equal to twenty-five percent (25%) of the 50/50 cash prize awarded (such amount being referred to herein as the "<u>Withholding Amount</u>") if the value of the prize exceeds \$5,000 and the winner is a citizen or resident alien of the United States with a Social Security number (different rules as promulgated by the Internal Revenue Service apply for nonresident aliens and for resident aliens and citizens of the United States who do not have a Social Security number) or as otherwise required by law.

 - Bonus Prize #3 (1): Two (2) pairs of Oakley sunglasses (the Tampa Bay Buccaneers collection) (ARV: \$410.00);
 - Bonus Prize #4 (1): Two (2) night stay at *Island Grand Beach Resort* or *RumFish Beach Resort* (ARV: \$750.00);
 - Bonus Prize #5 (1): Tampa Bay Buccaneers Cruise for two (2) with *Celebrity Cruises* (ARV: \$1,400); and

- Bonus Prize #6 (1): Gameday Getaway package that includes tickets for winner and one (1) guest to a Tampa Bay Buccaneers away game during 2023 regular season, roundtrip airfare (charter flight from Tampa, Florida), ground transfers only in Tampa and away game city, and two (2) meals (\$1,100).
- 12. The winning raffle number for a bonus prize will still be entered into the draw for the remaining bonus prize drawings. All winning raffle numbers for the bonus prizes will still be entered into the draw for the 50/50 cash prize (i.e., winning a bonus prize(s) does not affect the chances for the winner of the bonus prize to also win the 50/50 cash prize). The odds of winning depend on the total number of Raffle Tickets distributed.

PRIZE RESTRICTIONS

- 13. All prize details shall be at the Foundation's sole discretion. Each winner assumes sole responsibility for all expenses and incidental costs associated with the prize not explicitly outlined above, including without limitation, all federal, state and local taxes (if any), surcharges, fees, tips, gratuities, parking, concessions, souvenirs, merchandise, all transportation, travel or lodging, food, beverages, snacks, and personal items. - 19. Raffle Tickets will be available beginning April 24, 2023 at 12:00 PM ET and ending at the conclusion of the 2023 NFL Draft on April 29, 2023 (the "Promotion Period"). Raffle Tickets may be obtained online throughout the Promotion Period. Raffle Tickets will also be available at the Draft Celebration on April 27, 2023. To obtain Raffle Tickets:
 - a. <u>Draft Celebration In-Person at Kiosks</u>: Raffle Tickets will be available on April 27, 2023 starting at 7:00 PM ET and ending at 10:30 PM ET at one (1) or more stationary selling locations on the concourses in the Draft Celebration space at Stadium (each, a "<u>Kiosk</u>") (see below for Suggested Minimum Contribution);
 - <u>Draft Celebration In-Stadium Raffle Sales Representatives</u>: Raffle Tickets will be available on April 27, 2023 starting at 7:00 PM ET and ending at 10:30 PM ET throughout the Stadium from uniformed Raffle Sales Representatives (see below for Suggested Minimum Contribution);
 - c. <u>Online Sales</u>: Raffle Tickets will be available to purchase online by visiting <u>http://www.buccaneers.com/5050</u> throughout the Promotion Period (see below for <u>Suggested Minimum Contribution</u>); DATA CHARGES MAY APPLY TO USE OF MOBILE PHONE/DEVICE TO PARTICIPATE IN THE IN THE RAFFLE;

"<u>Suggested Minimum Contribution</u>" for Raffle Tickets is as follows:

d. <u>NO CONTRIBUTION OR PURCHASE NECESSARY</u>: You may obtain <u>Raffle</u> <u>Tickets</u> without making a purchase or contribution by completing and submitting an official raffle form available <u>here</u>. Additionally, if you are inside the Stadium during the Draft Celebration on April 27, 2023, you may visit the Stadium Kiosk in the Lower Concourse near Section 106/107. A request for and receipt of a <u>Raffle</u> <u>Ticket</u> constitutes your full and unconditional agreement to and acceptance of these Official Rules, including all entry requirements.

These are the only methods of obtaining Raffle Tickets. <u>Raffle Tickets will not be</u> distributed via U.S. mail, e-mail, or any method other than described above.

20. Raffle Tickets will only be distributed via In-Person Kiosks and In-Stadium Raffle Sales Representatives during the Draft Celebration until 10:30 PM ET on April 27, 2023. Raffle Tickets will be distributed online during the Promotion Period until the end of the 2023 NFL Draft. The Foundation is not responsible for Raffle Tickets that are lost, misdirected, garbled, distorted, truncated, incomplete, illegible, damaged, defaced, altered, tampered with, counterfeit, unauthenticated, copied or incorrect for any reason, and all such Raffle Tickets are void. WINNING TICKET SELECTION, ANNOUNCEMENT AND WINNER VERIFICATION

- 21. 50/50 Cash Prize Drawing: Following the 2023 NFL Draft on April 29, 2023, or within a reasonable time thereafter, the Foundation or its designee will randomly choose the number of one (1) Raffle Ticket from all Raffle Tickets timely distributed during the Raffle.
- 22. Bonus Prize Drawings: In addition to the 50/50 cash prize drawing described above, the Foundation or its designee will randomly choose six (6) numbers at select times during the Draft Celebration (as solely determined by Foundation) from all Raffle Tickets distributed prior to the applicable bonus drawing times.
- 23. Subject to verification of eligibility, the person who presents the Raffle Ticket with the matching winning ticket number(s) (the "<u>Winning Raffle Ticket</u>") (including and bonus prize winning number) during the Claims Period (defined below) will be declared the winner. The winning ticket numbers will be published to the Raffle Page within twenty-four (24) hours of the applicable drawing.

Upon presentation of a Winning Raffle Ticket during the Claims Period, the Foundation will verify that such Raffle Ticket bears the winning ticket number(s) and is the authentic Winning Raffle Ticket and thereafter may require to retain the Winning Raffle Ticket. In such an event, The Foundation will post notice of same at the Raffle Page and select the winning ticket number(s) at random from all non-suspect Raffle Tickets distributed prior to the suspension, cancellation or termination of the Raffle.

otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
