AUGUST 11, 2023 TAMPA BAY BUCCANEERS FOUNDATION 50/50 RAFFLE PROMOTION -OFFICIAL RULES

- NO CONTRIBUTION OR PURCHASE NECESSARY TO ENTER OR WIN. A CONTRIBUTION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The August 11, 2023 Tampa Bay Buccaneers Foundation 50/50 Raffle Promotion (the "<u>Promotion</u>") is sponsored by the Tampa Bay Buccaneers Foundation, Inc. (the "<u>Foundation</u>"), a Section 501(c)(3) tax-exempt organization with its principal place of business at AdventHealth Training Center, One Buccaneer Place, Tampa, Florida 33607. The Foundation is the official charity of the Tampa Bay Buccaneers Football club (the "<u>Buccaneers</u>"). Promotion is only offered in the state of Florida (the "<u>Promotion</u> <u>Area</u>"). - 2. Prize is funded by the Foundation or donated by the Buccaneers. No refunds will be made, except as otherwise determined by the Foundation in its sole discretion. Raffle ticket (each a "<u>Raffle Ticket</u>") purchases are not tax deductible. Making a contribution or donation will not improve your chances of winning.
- 3. Promotion is subject to all federal, state and local laws. The Foundation shall be entitled to interpret these Official Rules as needed including but not limited to rules regarding Raffle Tickets, deadlines, winning ticket number selections, prize restrictions, and eligibility and all its decisions are final. By participating, you irrevocably, fully and unconditionally agree to be bound by these Official Rules and waive any right to claim ambiguity in these Official Rules and or any other Promotion-related advertising or materials.
- 4. Promotion begins on July 30, 2023 at 7:00 AM Eastern Time ("<u>ET</u>"). Raffle Tickets will be available online throughout the <u>Promotion Period (defined below</u>). Raffle Tickets will also be available during the Buccaneers home game at Raymond James Stadium (the "<u>Stadium</u>") on August 11, 2023 (the "<u>Bucs Game</u>") beginning when public parking lots at the Stadium open for the Bucs Game. Raffle Tickets are only valid for the drawing to be held on August 11, 2023.
- 5. Final deadline to obtain or request <u>Raffle Tickets</u> is the end of the Bucs Game on August 11, 2023. Stadium scoreboard will be the official time-keeping device for the Promotion.
- 6. Please note that National Football League ("<u>NFL</u>") game dates and times and gate opening times are determined in the sole discretion of the NFL and/or the <u>Buccaneers</u>, as applicable, and are subject to change. If the <u>Bucs Game</u> is not played for any reason, the Promotion will not be held. For Promotion information and announcements, visit <u>http://www.buccaneers.com/5050</u> (the "<u>Promotion Page</u>").
- 7. Winner will be issued an IRS 1099 MISC tax form (or its equivalent or other required documentation and/or reporting forms) for the ARV of the prize awarded if required and is solely and exclusively responsible for all state, federal or local income taxes that may result from his or her acceptance of the prize(s). The Foundation is required by law to withhold and remit to the Internal Revenue Service on the winner's behalf an amount equal to twenty-five percent (25%) of the 50/50 cash prize awarded (such amount being referred to herein as the "Withholding Amount") if the

- 13. The winning raffle number for a bonus prize will still be entered into the draw for the remaining bonus prize drawings. All winning raffle numbers for the bonus prizes will still be entered into the draw for the 50/50 cash prize (i.e., winning a bonus prize(s) does not affect the chances for the winner of the bonus prize to also win the 50/50 cash prize).
- 14. All prize details shall be at the Foundation's sole discretion. Each winner assumes sole responsibility for all expenses and incidental costs associated with the prize not explicitly outlined above, including without limitation, all federal, state and local taxes (if any), surcharges, and fees. - 18. <u>Raffle Tickets</u> will be available beginning July 30, 2023 at 7:00 AM ET and ending at the conclusion of the <u>Bucs Game</u> on August 11, 2023 (the "<u>Promotion Period</u>"). Raffle Tickets may be obtained online throughout the Promotion Period. Raffle Tickets will also be available at the Bucs Game on August 11, 2023. To obtain Raffle Tickets:
 - <u>Online Sales</u>: Raffle Tickets will be available to purchase online by visiting <u>http://www.buccaneers.com/5050</u> throughout the Promotion Period (see below for <u>Suggested Minimum Contribution</u>);
 - b. <u>In-Person at Kiosks</u>: Starting at approximately ninety (90) minutes before kick-off on the day of the <u>Bucs Game</u>, Raffle Tickets may be available at up to eight (8) stationary selling locations on the concourses at the <u>Stadium</u> ("<u>Kiosks</u>"), in the following Sections: Section 211 – West Club; Section 234 – East Club; Section 106 – Lower West Concourse; Section 115 – Lower West Concourse; Section 131 – Lower East Concourse; Section 140 – Lower East Concourse; Section 310 – Upper West Concourse; Section 333 – Upper East Concourse (see below for Suggested Minimum Contribution);

c. <u>In-Stadium Raffle Sales Representatives</u>: Starting at approximately ninety (90) minutes before kick-off on the day of the Bucs Game, Raffle Tickets will be available throughout the Stadium from uniformed Raffle Sales Representatives (see below for Suggested Minimum Contribution);

"Suggested Minimum Contribution" for Raffle Tickets is as follows:

- For Raffle Tickets purchased between the start of the Promotion Period (July 30, 2023 at 7:00 AM ET) through August 10, 2023 (ending at 11:59:59 PM): \$10 for (10) Raffle Tickets, \$25 for fifty (50) Raffle Tickets, \$50 for two hundred (200) Raffle Tickets, and \$100 for eight hundred (800) Raffle Tickets;
- For Raffle Tickets purchased on the day of the Bucs Game (beginning at 12:00:00 AM) through the conclusion of the Promotion Period (end of the Bucs Game): \$10 for five (5) Raffle Tickets, \$25 for twenty (25) Raffle Tickets, \$50 for one hundred (100) Raffle Tickets, and \$100 for four hundred (400) Raffle Tickets; or
- d. <u>NO CONTRIBUTION OR PURCHASE NECESSARY</u>: You may obtain <u>Raffle</u> <u>Tickets</u> without making a purchase or contribution by completing and submitting an official raffle form available <u>here</u>. Additionally, if you are inside the Stadium, you may visit the Stadium Kiosk in the Upper East Concourse near Section 333 during the <u>Promotion Period</u>. A request for and receipt of a <u>Raffle Ticket</u> constitutes your full and unconditional agreement to and acceptance of these Official Rules, including all entry requirements.

These are the only methods of obtaining Raffle Tickets. <u>Raffle Tickets will not be</u> <u>distributed via U.S. mail or any method other than described above</u>. DATA CHARGES MAY APPLY TO USE OF MOBILE PHONE/DEVICE TO PARTICIPATE IN THE PROMOTION.

- 19. Regardless of method, <u>Raffle Tickets</u> will only be distributed as described above and until the end of the <u>Bucs Game</u> on August 11, 2023. Non-winning Raffle Tickets are not valid for subsequent promotions, if any.

The Foundation is not responsible for Raffle Tickets that are lost, misdirected, garbled, distorted, truncated, incomplete, illegible, damaged, defaced, altered, tampered with, counterfeit, unauthenticated, copied or incorrect for any reason, and all such Raffle Tickets are void. The Foundation reserves the right in its sole discretion to disqualify any Raffle Ticket at any time that in its opinion does not comply with these Official Rules.

WINNING TICKET SELECTION & ANNOUNCEMENT; WINNER VERIFICATION

- 21. 50/50 Cash Prize Drawing: Following the <u>Bucs Game</u> on August 11, 2023, or within a reasonable time thereafter, the Foundation or its designee will randomly choose one (1) Raffle Ticket from all Raffle Tickets timely distributed during the Promotion Period.
- 22. Bonus Prize Drawings: In addition to the 50/50 cash prize drawing described above, the Foundation or its designee will randomly choose four (4) numbers at select times during

the Promotion Period (as solely determined by Foundation) from all Raffle Tickets distributed prior to the applicable bonus drawing times.

- 23. Subject to verification of eligibility, the person who presents the Raffle Ticket with the matching winning ticket number(s) (the "<u>Winning Raffle Ticket</u>") (including any bonus prize winning number) during the <u>Claims Period (defined below</u>) will be declared the winner. The winning ticket numbers will be published to the Promotion Page within twenty-four (24) hours of the applicable drawing. You do not have to be present to win.

Verification Requirements

- 26. - 27. Upon presentation of a <u>Winning Raffle Ticket</u> during the <u>Claims Period</u>, the Foundation will verify that such Raffle Ticket bears the winning ticket number(s) and is the authentic Winning Raffle Ticket and thereafter may require to retain the Winning Raffle Ticket. Within thirty (30) days of the winner's compliance with the foregoing verification requirements and procedures, the verified winner(s) will receive instructions on claiming or receiving their prize(s). If any prize is mailed or shipped, such winner shall assume all risk of loss, damage, theft, late or missed delivery. the Foundation shall mail a check in payment of the prize, less the <u>Withholding Amount</u>, if any, to the winner at his/her <u>Mailing Address</u>.
- 28. If a potential winner fails to timely present the Winning Raffle Ticket, fails to timely and completely satisfy any eligibility or verification requirement herein, declines to accept the prize(s), or is otherwise determined to be ineligible, the Foundation in its discretion may disqualify that individual and he/she will forfeit the prize.
