OFFICIAL RULES

The Buccaneers Mobile App Giveaway Sweepstakes (the "Promotion") is intended for legal residents of the continental United States (collectively the "Participating States") and shall only be construed and evaluated according to U.S. law and laws of the State of Florida. <u>How to Participate</u>: You must have a compatible iOS or Android smartphone, tablet or other mobile device prior to each Entry Period to be eligible. To play, you must complete each of the following steps:

Step 1: Get the Bucs App: To participate, you must have a compatible smartphone or other wireless or mobile device and you must download the free official Tampa Bay Buccaneers mobile application (the "<u>Bucs App</u>"), from the Google Play Store (Android Market) or the Apple iTunes Store. Your participation in this Promotion will be subject to your agreement to, and compliance with, the applicable terms and conditions governing the use of the Bucs App.

Step 2: Enable Push Notifications: Enable push notifications through your phone settings as well as in the Bucs App (notifications for Contests and Promotions must be turned on). The Bucs App will randomly send out two (2) push notifications during each Entry Period (1 at the beginning of the month and 1 towards the end of the month).

Step 3: Complete Entry Form: Once the notification from Bucs App appears, tap the notification to open the app, then fill out the entry form and click submit. The entry window will remain open until the end of the applicable Entry Period. You may only enter once per Entry Period regardless if multiple push notifications were sent out that month.

Winner Selection/Verification:

On the day following each Entry Period, or within a reasonable time thereafter, Sponsor or its designee will randomly choose one (1) name from all timely entries received during the applicable Entry Period. Subject to verification of eligibility, the person whose name is so drawn will be declared the winner.
