

## **BUCCANEERS MOBILE APP GIVEAWAY SWEEPSTAKES**

### **OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS PROMOTION.  
A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING.

The Buccaneers Mobile App Giveaway Sweepstakes (the "Promotion") is intended for legal residents of the continental United States (collectively the "Participating States") and shall only be construed and evaluated according to U.S. law and laws of the State of Florida. Do not enter this Promotion if you are not a legal resident of the Participating States at the time of entry. Void in the State of Rhode Island, outside of the continental United States, and where prohibited by law.

**Sponsor:** The Promotion is sponsored by Buccaneers Team LLC, AdventHealth Training Center, One Buccaneer Place, Tampa, FL 33607 (the "Sponsor").

**Eligibility:** The Promotion is open and offered only to legal U.S. citizens that are residents of the Participating States who are eighteen (18) years of age or older at the time of entry (the "Entrants"). Employees of Sponsor or its affiliates, parent companies, marketing agencies, contest vendors, subsidiaries and advertising and promotion agencies, any contractors working directly on the Promotion and the immediate family members or those living in the same household of each are not eligible to participate. Sponsor reserves the right, at any time, to verify eligibility requirements, in any manner it deems appropriate.

**Promotion Period:** The Promotion will run through the duration on the 2024 NFL Draft (the "Draft"), beginning on April 25, 2024 at 8:00 PM Eastern Time ("ET"). Final entry deadline is immediately following the Draft (*approximately 7:00 p.m. on April 27, 2024*). Drawing to determine potential winner will be held on April 28, 2024. Sponsor's computer is the official time-keeping device for this Promotion. Draft dates and times are determined in the sole discretion of the NFL and are subject to change.

**How to Participate:** You must have a compatible iOS or Android smartphone, tablet or other mobile device prior to or during the Draft to be eligible. To play, you must complete each of the following steps:

**Step 1: Get the Bucs App:** To participate, you must have a compatible smartphone or other wireless or mobile device and you must download the free official Tampa Bay Buccaneers mobile application (the "Bucs App"), from the Google Play Store (Android Market) or the Apple iTunes Store. Your participation in this Promotion will be subject to your agreement to, and compliance with, the applicable terms and conditions governing the use of the Bucs App.

**Step 2: Enable Push Notifications:** Enable push notifications through your phone settings as well as in the Bucs App (notifications for Contests and Promotions must be turned on). The Bucs App will randomly send out a push notification during Day 1 of the Draft (i.e., the First Round which begins at 8:00 pm ET on April 25, 2024) and during Day 3 of the Draft (i.e., the Fourth-Seventh Rounds which begins at 12:00 pm ET on April 27, 2024).

**Step 3: Complete Entry Form:** Once the notification from Bucs App appears, tap the notification to open the app, then fill out the entry form and click submit. The entry window will remain open until the end of the Draft. You may only enter once regardless of multiple push notifications.

### **Winner Selection/Verification:**

On the day following the Draft, or within a reasonable time thereafter, Sponsor or its designee will randomly choose one (1) name from all timely entries received during the Promotion Period. Subject to verification of eligibility, the person whose name is so drawn will be declared the winner.

Limit one (1) prize.

Sponsor will contact the potential winner using the e-mail address provided by winner on his or her entry form. The winner must respond to Sponsor within forty-eight (48) hours of initial notification and may be required to present valid photo identification and/or to sign an affidavit or declaration of eligibility, liability waiver, publicity release (where legal), tax forms and/or other legal documents and to provide such documents to Sponsor. Sponsor in its sole discretion may allow for transmission of verification documents via fax or e-mail. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN TAMPA, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
