# 2020 RENEWAL & SEASON PASS CAMPAIGN OFFICIAL RULES

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The 2020 Renewal & Season Pass Campaign (the "Promotion") is sponsored by Buccaneers Team LLC ("Sponsor"). Promotion is only offered to legal residents of the state of Florida (the "Promotion Area"). Void outside the Promotion Area and where prohibited.
- 2. Promotion is subject to all federal, state and local laws. Sponsor shall be entitled to interpret these Official Rules as needed including but not limited to rules regarding entries, deadlines, winner selection, prize restrictions, and eligibility and all its decisions are final and binding in all Promotion-related matters. Sponsor's computer is the official time-keeping device for this Promotion.
- 4. Tax Documents: If required for any prize, winner will be issued an IRS Form 1099-MISC (or its equivalent) reflecting the ARV of that prize, and he or she will be solely and exclusively responsible for all state, federal or local income taxes that may result from his or her acceptance of the prize.

# SPECIFIC PRIZE RESTRICTIONS

- 25. <u>Bucs Merchandise Prize Restrictions</u>: No particular autographing player is guaranteed for any merchandise items. The player autograph prizes or prize elements have no cash value and are subject to the sole discretion of Sponsor. For individuals who renewed or purchased 2020 Tampa Bay Buccaneers Season Tickets prior to the start of the Entry Period, such individuals will be automatically entered into the Promotion. - 45. Sponsor will contact each potential winner using the information supplied by winner on his or her entry form.
