PROMOTION OFFICIAL RULES

<u>**How to Participate**</u>: At approximately 11:00 AM EDT during each Entry Period listed in the Promotion Chart, Sponsor will post a series of clues describing a specific person, place/location, or event (the "Treasure Drop"). From the clues, fans will be able to guess the Treasure Drop.
