

BUCS TREASURE DROP
PROMOTION OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS PROMOTION.
A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING.

The “Bucs Treasure Drop” Promotion (the “Promotion”) is intended for legal residents of the continental United States (collectively the “Participating States”) and shall only be construed and evaluated according to U.S. law and laws of the State of Florida. Do not enter this Promotion if you are not a legal resident of the Participating States at the time of entry. Void in the State of Rhode Island, outside of the continental United States, and where prohibited by law.

Sponsor: The Promotion is sponsored by Buccaneers Team LLC, AdventHealth Training Center, One Buccaneer Place, Tampa, FL 33607 (the “Sponsor”).

How to Participate: At approximately 11:00 AM EDT during each Entry Period listed in the Promotion Chart, Sponsor will post a series of clues describing a specific person, place/location, or event (the “Treasure Drop”). From the clues, fans will be able to guess the Treasure Drop.

To be eligible to participate in the Promotion, the Entrant must enter by visiting <https://www.buccaneers.com/treasuredrop> (the “Promotion Page”) and following the instructions to complete the registration form with all required information prior to the end of the Entry Period (which includes answering the Treasure Drop correctly).

Clues will be disseminated via Twitter and Facebook. If participating via a mobile phone or other web-enabled device and using your wireless carrier’s network, standard data charges from your wireless carrier may apply. This Promotion is in no way sponsored, endorsed or administered by, or associated with Facebook or Twitter.

Winner/Prize(s)/Verification:

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THESE OFFICIAL RULES OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
