

**“MVP’S IN THE CLASSROOM” SWEEPSTAKES  
OFFICIAL RULES**

**ELIGIBILITY:** NO PURCHASE NECESSARY TO ENTER OR REDEEM PRIZE. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. The “MVP’s In The Classroom” Sweepstakes (the “Sweepstakes”) is offered only in Arizona, and is open only to legal residents of Arizona age eighteen (18) or older and whose home address is located within sixty (60) miles of State Farm Stadium (the “Stadium”). Void where prohibited. The following persons are not eligible to participate: Employees, contractors, directors, and officers of Arizona Cardinals Football Club LLC; New Cardinals Stadium, LLC and University of Phoenix and their respective affiliates, or any company involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, “Promotion Parties”), and the NFL Entities (as defined below) and their respective immediate family members. “Immediate family members” means spouses, parents/guardians and children.

**SPONSOR AND ADMINISTRATOR:** Arizona Cardinals Football Club LLC is the Sponsor and the Administrator of the Sweepstakes.

**TIMING:** Sweepstakes begins at 12:01 AM Arizona Time (“AZT”), Monday, August 22nd, 2022 and, with respect to each drawing, the sweepstakes entry period ends at 11:59 PM AZT on the date which is three (3) days prior to the applicable drawing date (in each case, the “Drawing Deadline”). With respect to each drawing, the period commencing at the Start Time and ending at the applicable Drawing Deadline is referred to herein as the “Sweepstakes Period.” The Administrator’s computer is the official timekeeping device for the Sweepstakes.

**PRIZES:** With respect to each drawing, three (3) winners (selected in a random drawing from among the nominated teachers/educators) will each receive the following: four (4) tickets and one (1) parking pass to a Cardinals home game, four (4) pre-game field passes, one (1) Cardinals jersey and \$500 towards classroom supplies.  
Approximate retail value of each prize: \$1,000.

**HOW TO ENTER:** During the applicable Sweepstakes Period, visit [www.azcardinals.com/mvp](http://www.azcardinals.com/mvp) and include your name, address, phone number and email address, along with the name, address, phone number and email address of one (1) teacher/educator you wish to nominate. At the option of the entrant, the submission may also include a short essay stating why that teacher/educator should be considered an “MVP In The Classroom”. However, inclusion of such content will not impact the odds that any entry will be selected as a winner.

For alternate mode of entry, print your name, address (which must be within sixty (60) miles of the Stadium), phone number and e-mail address (if available), along with the name, address (which must be within sixty (60) miles of the Stadium), phone number and e-mail address (if available) of the teacher/educator being nominated on a piece of paper and mail it to: Arizona Cardinals, Attn: “MVP’s In The Classroom” Sweepstakes, P.O. Box 888, Phoenix, AZ, 85001-0888. At the option of the entrant,

the submission may also include a short essay stating why that teacher/educator should be considered an “MVP In The Classroom”. However, inclusion of such content will not impact the odds that any entry will be selected as a winner. Entries for each drawing must be received no later than 5:00 PM AZT on the day of the Drawing Deadline. Mailed entries must be postmarked by the applicable Drawing Deadline and received no later than 5:00 PM AZT on the third day after the applicable Drawing Deadline. Limit one entry per person during the entire Sweepstakes Period. Winning entries will not be eligible for participation in subsequent drawings. Entries not selected in each drawing automatically will be entered into the subsequent drawings. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different identities or any other method will void that person’s entries and that participant may be disqualified. Mail-in entries must be handwritten and may not be photocopied, printed by machine, computer printed or otherwise mechanically reproduced. The Promotion Parties are not responsible for lost, interrupted or unavailable mail-in entry forms whether human, mechanical or electronic, including without limitation, the incorrect or inaccurate capture of entry information regardless of cause. Once submitted, entries become the exclusive property of Arizona Cardinals Football Club and will not be acknowledged or returned.

**GENERAL CONDITIONS:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fire, flood, earthquake, epidemic, explosion, labor dispute or strike, act of public enemy, equipment failure, riot or civil disturbance, war or other military action, terrorist threat or activity, government order, fraud, technical failures or any other factor beyond Sponsor’s reasonable control (including any labor dispute affecting the National Football League) (a “Force Majeure Event”) impairs the integrity, feasibility or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

In the event that this Sweepstakes is challenged by a legal or regulatory authority, Sponsor reserves the right to discontinue or modify the Sweepstakes, or to disqualify entrants residing in the affected geographic areas. In such an event, the Promotion Parties shall have no such liability to any entrants who are disqualified due to such action.

**LIMITATION OF LIABILITY:** By participating in the Sweepstakes, entrants and winners release the Promotion Parties and the NFL Entities and their respective officers, directors, employees, agents and affiliates from any and all claims, damages or liabilities arising from or relating to such entrant's participation in the Sweepstakes. By accepting a prize, (a) each entrant and winner agrees that the Promotion Parties will have no liability whatsoever for, and shall be held harmless against, any liability for injuries, losses or damages of any kind to persons or property resulting in whole or in part, directly or indirectly, from participation in the Sweepstakes or from acceptance, possession, misuse or use of any

prize (including any such liabilities arising during transportation to or from the Stadium) and (b) each entrant and winner grants (and agrees to confirm grant in writing promptly upon request) to the Promotion Parties, Sponsor and those acting under Sponsor's authority, the right to the use of his/her name, photograph, likeness, voice, image, statements (including the contents of any essay submitted as part of an entry) and biographical information, at any time or times, for advertising, trade, publicity and promotional purposes in any media now known or hereafter discovered, worldwide, including the World Wide Web without review, notification or approval, and additional compensation, unless prohibited by law. Sponsor is not liable in the event that any portion of the Sweepstakes or prize is canceled due to any Force Majeure Event.

**DRAWINGS:** Eight (8) random drawings will be conducted on the drawing dates identified below. At each drawing, three (3) winners will be selected from among the nominated teachers/educators via a random drawing from all eligible entries received during the applicable Sweepstakes Period. Each random drawing will be conducted by the Administrator, whose decisions will be final, binding and conclusive in all matters relating to the Sweepstakes. Each drawing will be conducted at a location to be determined by the Administrator.

**ODDS OF WINNING:** The odds of winning depend on the number of eligible entries received.

**MISCELLANEOUS:** Potential winners will be notified by email at the email address indicated on their entry form. The potential winner will be required to respond to the email within 48 hours indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate winner will be selected. Any alternate winners selected will also be required to respond to the email within 48 hours. Winners will be required to complete, sign and return an Affidavit of Eligibility/Liability Release and, where lawful, Publicity Release within five (5) days of prize notification. Winners' guests will also be required to complete and sign a Liability Release within the same time frame. If a guest is a minor, the Liability Release must be completed by the minor guest's parent or legal guardian and minor guest must attend the event with his/her parent or legal guardian. If attempted notification is returned as undeliverable, if any required documents are not returned within the required number of days, if winner cannot be verified, or if winner is otherwise unable to accept the prize as stated, prize will be forfeited and may be awarded to an alternate winner. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute prize with another prize of equal or

greater value. Games are subject to availability. Children attending the game must be accompanied at the game at all times by a parent or legal guardian. Seating assignments at the game are at the sole discretion of the Sponsor. Transportation, lodging, meals, beverages, gratuities, and all other expenses not specified herein are winner's responsibility. Winner must accept prize as stated, or prize will be forfeited and awarded to an alternate winner. No prize transfer. No prize substitution or cash equivalent of prize except at sole discretion of Sponsor for a prize of equal value, due to unavailability of prize for any reason. DISPUTES: Except where prohibited, each entrant and winner agrees that (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively in accordance with the laws of the State of Arizona, without regard to its choice of law rules and entrant consents to the jurisdiction and venue of the federal, state and local courts located in Maricopa County, Arizona; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorney's fees; and (3) under no circumstances will entrant or winner be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Arizona, without giving effect to any choice of law or conflict of law rules (whether of the State of Arizona or any other jurisdiction) which would cause the application of the laws of any other jurisdiction.
