



Guests recording practice may be ejected from State Farm Stadium.

All guests grant to the NFL, Arizona Cardinals Football Club LLC, and their designees the irrevocable permission to use his or her voice or likeness in any media now or hereafter existing in connection with all or any part of the Event related events, for any purpose whatsoever, including the commercial purposes of the NFL, the Arizona Cardinals Football Club LLC, their sponsors, licensees, advertisers or broadcasters.
