The Promotion is in no way sponsored by, endorsed by, administered by, or associated with any third party social media site, including Facebook<sup>®</sup>, Instagram<sup>®</sup>, and Twitter<sup>®</sup> (each, a "Social Media Outlet" and collectively, "Social Media"). Entrants acknowledge and agree that Align Technology, Inc.'s ("Align") sole role in the Sweepstakes is that of a Prize supplier and that Align is in no way responsible for the administration of the Sweepstakes or the selection of winners
- 2. ELIGIBILITY.
